- II. (i) The function of the Co-ordination Committee of Archives is to implement the main functions of a State Record Office as follows:—
  - (a) To concentrate in a single repository all the non current records, both Confidential and non-confidential of the State secretariat and the subordinate authorities to it whether at the headquarters or elsewhere including District Division and collectorate records and similar records of the High Court and other court;
  - (b) To house them in a properly equipped building:

(c) To arrange and clarify them on Scientific principles;

(d) To take such measures as are required; for their preservation and rehabilitation;

(e) To make them available both to the Official and Non-Official users:

- (f) To provide the records with necessary reference media such as summary and detailed inventories, and books etc.
- (ii) The Committee may fix a Chronological limit of 20 or 25 years whichever may suit the Departments concerned or the State Rocord Officer for transfer of records. The term records for this purpose would include documents, rolls, codices, sheets, files, dossiers, microfilens, photographs, charts, plans, diagrams, maps, sound recording etc.
  - (iii) Records pertaining to body becoming defunct with no seccessor taking over its functions, should be transferred to the State Archives soon after the body is defunct.
  - (iv) In the State Record Office, the following special types of records may be concentrated:—

Private papers, business Records, Elessiastical records, Municipal records, University records. Co-Operative Societies, Village Committees and other Organisations and family records etc.

NORTH: Starting from Tuirial River, It follows the Tuiphu riverlet upwards (i.e. to the East west) then Crosses BRTF Road at Quary North of Khanpui and Passes Chalfilh ridge East-wards meets Tuivawl River.

**EAST** : From Tuivawl river and along Tuivawl river South-wards. It reaches an EGS Road South of Phullen.

: From the Crossing point of E.G.S. Tuivawl, it goes west-wards and SOUTH joints with Tuirini river, then meets with Tuirial river.

From joining place of Tuirini and Tuirial, the boundary line follows WEST downwards along Tuirial river and reaches upto Tuiphu riverlet ending the boundary.
