ANNEXURE - A

BOUNDARY DESCRIPTION OF TUIPANG FOREST RANGE

STARTING POINT :- BRTF Road Crossing of R. Kawlchaw at Kawlchaw.

- NORTH:** From starting Point it runs along R. Kawlchaw towards its source. Along Inter-Village boundary between Theiva and Theiri it crosses BRTF Road and extends along the Inter-Village boundary, till it meets source of R. Tuisih.
- EAST :** Along the course of R. Tuisih it extends southwards till it meets international boundary between Burma and India within Khopai Village council land where R. Tuisih meets R. Tisi. Following R. Tisi along the East towards South it extends upto Inter-village boundary between Laki and Lungpuk.
- SOUTH :** From Inter-Village boundary between Laki Village and Lungpuk it runs along the Inter-Village boundary between Khopai and Mipu villages. In between Khopai and Vahai it meets E.G.S. Road of Tuipang-Tongkolong and follow the E.G.S. Road upto Vahai Village.
- WEST :** From Vaphai village it runs along the Inter-Village boundary between Vahai and Hmakytla and meets R. Palak near Hmakytla. Along the course of Palak it extends northwards till it meets inter District boundary between Pawi District Council and Lakher District Council between Pawi District Council and Lakher District Council it runs northeast and curve within Latawh Village Council area till it meets Kawlchaw the starting point in the North.

ANNEXURE—B

BOUNDARY DESCRIPTION OF NGENGPUI FOREST RANGE

- NORTH :** The boundary starts from the mouth of River Kawrawng and follows the river Kawrawng up stream westwards upto the stream-let of Kawrawng.

WEST : It follows the stream-let of Kawrawng upto its sources and crosses the saddle and join the source of river Diphai. Thence follows of Diphai upto its sources and thence down the river Sialphai upto the stream-let upto the source of river Zawhlet.

SOUTH : It follows the river Zawhlet east wards and meets the river Ngengpui and goes down the river Ngengpui upto the south of river Tuiphal. Thence it follows the river Tuiphal upto the mouth of Sihlui.

EAST : From the mouth of Sihlui it follows Sihlui North-wards upto its sources thence down the river Ramhuai lui upto the river Pawiawh and runs appresimately 2 Km from Ngengpui upto Hlumpuilui and follows down wards upto its mouth to Ngengpui. Hence it follows the river Ngengpui north wards upto the south of river Kawrahng from where the boundary starts.
