NOTIFICATION

No. LAD/VC-4/84/(A), the 18th December 1984. Instances have come to the notice of the Govt. that after Gov't. Department undertake correspondence with the Village Council Presidents of various Village Councils and insist for an early reply. The offices of the Village Councils of Village Council Presidents are not properly equipped nor are they provided funds for purchase of stationeries etc.

- 1. It has therefore, been decided that the Govt. Departments/offices which may utilise the services of Village Councils for any purpose shall supply the Village Councils with stationeries and other materials to comply with the request made by the Govt. Departments from time to time.
- 2. The Village Councils being an elected body having a most important administrative functioneries at Village level deserves due courtasy to be shown to the Village Council Presidents and the members of the Village Council.

It has therefore been decided that henceforth, official correspondence to Village Councils should be addressed with "Ka pu" and ending with either "I thawhpui or I rintlak".

- 3. It is also informed tion the services of the Village Councils through the Director of Local Administration when the services of the Village Council is requisitioned by any Department.
- 4. Correspondences with the Village Councils by Govt. Departments and offices should be made in local language, "Mizo tawng" as far as possible.
