2. The terms of reference of the Committee will be as follows :—

(1) To enquire into the prevailing rates of wages of persons engaged on Scheduled Employments.

(2) To advise and submit proposals to the Government of Mizoram in fixing the rates of Minimum Wages of such persons employed under any Scheduled employments.

(3) To recommend suitable enforcement machinery in the conditions of Mizoram and its modus operandi.

3. The terms of the Committee shall be for a period of 6 (six) months from the date of issue of this notification.

4. The Chairman and other Non-official members of the Committee will be entitled to T.A and D.A like Class I Officers of the Government.

5. The Committee is required to submit report within 6 months.
