Governor (Administrator) of the Union Territory of Mizoram is pleased to declare that the boundaries of the Lunglei Town shall be as indicated in the Annexure to the notification with immediate effect and until further orders. This supercedes the then District Council Executive Order (Revenue) No. 10 of 1970 issued under Memo. No. EP-6/LS-70/376 dated 17/12/1970.

BOUNDARY DESCRIPTION OF LUNGLEI TOWN AREA

Starting Point : To the north eastern corner at the town the boundary Pillar No. 1 is fixed to the eastern side of Lunglei-Aizawl road, at the distance of 300.00 mtrs. vertically from Pholeng Kawn of Zobawk ram. The Point is 22°49'52" Longitude. This point is used as the starting point of the boundary of the town.

A. E A S T

a) From the starting point, the boundary runs to southeast direction in paralleled to Aizawl-Lunglei Road and the pillar No. 2 is fixed at the saddle, to the north of Masi Lui. The point is 22°51'48" Latitude and 92°50'4" Longitude.

From this the boundary runs to southwards and pillar No. 3 is fixed at the confluence of stream which is $22^{\circ}51'9''$ Latitude and $92^{\circ}49'45''$ Longitude. From this the boundary again runs to south western direction and the pillar No. 4 is fixed at the northern bank of river Tlawng which point is $22^{\circ}50'44''$ Latitude and $92^{\circ}49'16''$ Longitude.

b) From the starting point of the boundary runs to western direction and pillar No. 51 is fixed at the eastern edge of Lunglei-Aizawl road and which place is known as Pholeng Kawn, the point is $22^{\circ}53'37''$ Latitude and $92^{\circ}49'41''$ Longitude. From this the boundary runs to westwards and the pillar No. 50 is fixed on the confluence of Pholenglui which point is $22^{\circ}52'35''$ Latitude and $92^{\circ}49'41''$ Longitude. From this the boundary runs to southwestern direction and pillar No. 49 is fixed on the spur which point is $22^{\circ}52'29''$ Latitude and $92^{\circ}48'55''$ Longitude. From this it deflects to southeast direction and pillar No. 48 is fixed at the confluence of Khurpului and the point is $22^{\circ}51'50''$ Latitude and $92^{\circ}49'25''$ Longitude. From this it again deflects to southwestern direction pillar No. 47 is fixed at the western bank of river Tlawng which point is $22^{\circ}51'10''$ Latitude and $92^{\circ}48'37''$ Longitude. From this the boundary runs westwards and pillar No. 46 is fixed at the confluence of stream which point is $22^{\circ}51'18''$ Latitude and $92^{\circ}46'0''$ Longitude. From this the boundary runs directly along $92^{\circ}48'0''$ Longitude line northwards and pillar No. 45 is fixed at the saddle, Meeting point with $22^{\circ}52'0''$ Latitude. From this again follows the said longitude line northwards and pillar 44 is fixed at the saddle which is the meeting place with $22^{\circ}52'54''$ Latitude line. From this the boundary follows small stream to westwards upto the confluence with Kharzawl Lui where pillar No. 43 is fixed. From this it again follows Kharzawl Lui to northwest direction upto the confluence with Ngharihlui and pillar No. 42 is fixed at this confluence. From this it follows Ngharih Lui to southwest direction and pillar No. 41 is fixed at the confluence with the stream which comes from Zohnuai kham. The point is $22^{\circ}53'19''$ Latitude and $92^{\circ}46'54''$ Longitude. From this the boundary follows the Zohnuai Kham lui toward upto the Zohnuai kham where pillar No. 40 is fixed. The point is $22^{\circ}53'17''$ Latitude and $92^{\circ}46'19''$ Longitude. From this the boundary deflects to northeast direction upto Chawlhmun Kawn of Zotlangram. The point is $22^{\circ}54'33''$ Latitude and $92^{\circ}46'38''$ Longitude. The pillar No. 39 is fixed at this point.

B. SOUTH

From pillar No. 4 as already mentioned in the East (a) the boundary runs to western direction and the pillar No. 5 is fixed along the ridge of Zopuitlang, at the point of $22^{\circ}50'33''$ Latitude and $92^{\circ}48'19''$ Longitude. From this the boundary runs to southwest direction upto Kham Har of Lunglei-Lawngtlai road and pillar No. 6 is fixed at this scarp. From this the boundary runs to southwestern direction and after crossing the Lunglei-Lawngtlai road it follows the small stream and the pillar No. 7 is fixed at the confluence of Vawnzawl Lui. The point is $22^{\circ}50'4''$ Latitude and $92^{\circ}47'50''$ Longitude. From this it deflects to western direction and pillar No. 8 is fixed on the spur which point is $22^{\circ}50'11''$ Latitude and $92^{\circ}29'50''$ Longitude. From this the boundary runs to northwards and pillar No. 9 is fixed at the confluence of Luithuam Lui with stream. The point is $22^{\circ}50'41''$ Latitude and $91^{\circ}47'43''$ Longitude. From this it runs to northwestern direction and.

pillar No. 10 is fixed on the spur which point is $22^{\circ}51'0''$ Latitude and $92^{\circ}47'26''$ Longitude. From this it runs directly to northwestern direction in parallel to Lunglei to Aizawl Road and pillar No. 11 is fixed at the confluence of Saisih Lui with small stream. The distance of this point from the Sethun-Kawn is 780.00 metres. From this it runs to western direction in parallel to the state road and pillar No. 12 is fixed at the confluence of Ngengpui Lui with the stream at a distance of 875.00 metres from Chawngdinga Lungphun Kawn. The point is $22^{\circ}51'42''$ Latitude and $92^{\circ}46'10''$ Longitude. From this the boundary runs to western direction and pillar No. 13 is fixed on the spur which point is $22^{\circ}51'34''$ Latitude and $92^{\circ}45'50''$ Longitude. This point is at the distance of 650.00 metres from Police point nearby Godown. From this the boundary deflects directly to southwards and pillar No. 14 is fixed on the spur which point is $22^{\circ}50'40''$ Latitude and $92^{\circ}45'50''$ Longitude. This point is at the distance of 2075 Kms from the Police Station nearby Godown. From this the boundary runs westwards and at the distance of 300.00 mts the pillar No. 15 is fixed on the western side of the spur which point is $22^{\circ}50'46''$ Latitude and $92^{\circ}45'40''$.

C. WEST

From Pillar No. 15 as mentioned above the boundary runs to north western direction along the scarp and pillar No. 16 is fixed on the hillock which point is $22^{\circ}51'20''$ Latitude and $92^{\circ}55'26''$ Longitude. From this the boundary runs to northwards and pillar No. 17 is fixed at the confluence of stream which is $20^{\circ}51'52''$ Latitude and $92^{\circ}45'23''$ Longitude. The point is at the distance of 350.00 Mts from Police station. From this the boundary runs to north western direction in parallel to Lunglei-Tabung road and pillar No. 18 is fixed at the confluence of stream which point is $22^{\circ}52'44''$ Latitude and $92^{\circ}44'43''$ Longitude. From this the boundary follows the Mauhak Lui to westerly direction and pillar No. 19 is fixed at the confluence of stream which point is $22^{\circ}52'34''$ Latitude and $92^{\circ}44'30''$ Longitude. From this it runs to western direction and pillar No. 20 is fixed at the confluence of stream which point is $22^{\circ}52'46''$ Latitude and $92^{\circ}44'12''$ Longitude. This point is at the distance of 750.00 Mtrs from Sazai Kawn. From this it deflects to southwards and pillar No. 21 is fixed on the spur which points is $22^{\circ}52'7''$ Latitude and $92^{\circ}44'16''$ Longitude. From this the boundary deflects to north western direction and pillar No. 22 is fixed at the confluence of Sazai Lui with stream which point is $22^{\circ}52'58''$ Latitude and $92^{\circ}43'29''$ Longitude. The distance of the point from pumpelh chhuah kawn i.e. entrance to Hauruang village is 375.00Mtrs. From this the boundary deflects to south westerly direction in parallel to Lunglei-Tabung road and boundary pillar No. 23 is fixed on the western bank of the stream which point is $22^{\circ}52'36''$ Latitude and $92^{\circ}43'15''$ Longitude. From this the boundary follows the stream to southwards and pillar No. 24 is fixed at the confluence of the stream which point is $22^{\circ}52'11''$ Latitude and $92^{\circ}43'20''$ Longitude from this boundary deflects to south western direction and pillar No. 25 is fixed site. Just North of Hauruang village and the point is $22^{\circ}52'0''$ Latitude and $92^{\circ}43'0''$ Longitude. The distance of the point from Hauruang Kawn is 400.00 Mtrs. From pillar No. 25 the boundary runs to northwards and pillar No. 26 is fixed bending point of Lunglei-Tabung road which point is $22^{\circ}52'32''$ Latitude and $92^{\circ}42'53''$ Longitude. From this the boundary runs to northwards and pillar (No. 27 is fixed

West M.E. School) from this the boundary runs to the northeast direction and pillar No. 28 is fixed at the confluence of the stream which point is $22^{\circ}53'15''$ Latitude and $92^{\circ}43'15''$ Longitude. From this the boundary follows the streams to eastwards and pillar No. 29 is fixed at the confluence of the stream which point is at the north of Pumpelh chhuah Kawn being at the distance of 300.00 Mtrs. From this point the boundary runs to northeast direction and pillar No. 30 is fixed at Chhumliam Kawn of Vanhne road which point is $22^{\circ}53'41''$ Latitude and $92^{\circ}43'37''$ Longitude. From this the boundary follows the stream to eastwards and pillar No. 31 is fixed at the confluence with R. Hmawngva Lui from this the boundary follow R. Hmawngva to northwards and pillar No. 32 is fixed at the confluence with Saisih Lui.

D. N O R T H

From pillar No. 32 as mentioned above the boundary follow Saisih Lui to eastwards and pillar No. 33 is fixed at the southern bank of the same nullah which point is $22^{\circ}54'33''$ Latitude and $92^{\circ}45'0''$ Longitude. The point is at the distance of 1.35 Kms from Baptist Hospital. From this the boundary runs directly to northwards along the $92^{\circ}45'0''$ Longitude line and pillar No. 34 is fixed at the confluence of stream which point is $22^{\circ}55'24''$ Latitude and $92^{\circ}45'0''$ Longitude. From this point the Lunglei—
