TERMS OF DEPUTATION OF SMT. LALZIKI SAILO, PROFESSOR, MIZORAM INSTITUTE OF EDUCATION: ALZAWL TO ZIRTIRI WOMEN'S COLLEGE

- 1. Period of deputation will be one year in the first instance.
- 2. Pay; During the period of deputation, Smt. Lalziki Sailo will have the option either to get her pay fixed in the deputation post under operation of the normal rules or to draw pay of the post held by her in her parent department in accordance with and subject to the conditions of the Ministry of Finance Memorandum No. 10(23)-E.III/60 dated 4. 5. 1961 as modified from time to time and such other general or special order issued by the Ministry of Finance under para 1(iii) of the O. M.
- 3. Dearness allowance: Smt. Lalziki Sailo will be entitled to dearness allowance under the rules of the parent Govt. or under the rules of the borrowing Board according as she retains her scale of pay under the parent Govt. or she drawn pay in the scale attached to the post under Borrowing Board.
- 4. Local allowance: Like Compensatory (City) allowances, H.R.A. to be recalculated under the rules of the lending Govt.
- 4. (A) Children's education allowance: During-the period of deputation Smt. Lalziki Sailo will be eligible to claim the Children's Education Allowance from the Borrowing Board as laid down in para 1 (a) of Finance Ministry's O. M. No. B. (II)-E.II(b)/63 dated 12. 8. 1964 subject to the fulfillment of the conditions prescribed in the O. M. No. F.-19(I)-Est(Spl)/60 dt. 1. 1962 as amended/clarified from time to time.
- 4. (B) Reimbursement of tuition fees: He will be entitled to reimbursement of tuition fees in respect of her children subject to the fulfillment of the terms and conditions laid down in Finance Ministry's O.M. No. F. 17(I)-E.III(B)/64 dated 3. 6. 1964 as amended/clarified from time to time and the liability in this regard will devolve on the borrowing Board.

Note: The Govt. servant cannot claim both the concession in respect of the same child.

- 5. Joining time: Pay & Transfer T. A.: She will be entitled to T. A. and joining time both on joining the post on deputation and on reversion therefrom to the parent Govt. under rules of Govt. from which she is deputed. The expenditure on this account will be borned by the borrowing Board.
- 6. T. A. for Journey on duty: During the period of deputation to be regulated under rules of Govt. from which she proceeds on deputation.
- 7. Leave and pension: During the period of deputation on temporary transfer, she will continue to subcribe to the Provident Fund of her parent Govt. to which she may be subscribing whom she is placed on deputation, in accordance with the rules of such Fund.

In case of deputation of a Govt, servant who is governed by the contributing Provident Fund Rules, Govt, of Contribution is payable by the Board to whom she is deputed, for the period of her deputation.

- 7 (B) Extra-Ordinary Pension/Gratuity: This will be regulated in accordance with the Ministry of Finance (Deptt. of Expenditure, O.M.NO.F.19 (23)-E.V (A)/64 dated 2.8.1965.
- 8. Leave Travel Concession: She will be entitled to these concessions under the rule of the lending Govt.
- 10. Residential Accommodation: She will be entitled to residential accommodation according to the rules of the Govt. from which she is deputed.

No free house or free car will be allowed, nor any conveyance will be provided at Govt. expense unless such benefits are normally attached as a condition of service to the post to which she is deputed.

Starting from the crossing point of southern boundary of INNER LINE RESERVE FOREST and the SERLUI RIVER, the boundary follows the INNER LINE RESERVE FOREST boundary lines towards east upto the TUIRIAL RIVER which is the inter Division boundary of Kolasib and Darlawn Forest Division.

EAST:

Thence the boundary follows the TUIRIAL RIVER, the inter Division boundary, upstream upto the confluence of the TUIRINI.

SOUTH:

Thence the boundary follows the Tuiritai upstream and then follows the deeder, KELBO LUI upstream from its mouth to the TUIRIAL upto its (Kelbo lui) source. Thence crossing Serkhan-Saipum Jeep Road boundary comes over to the source of RAMRI-KAWR. Thence it follows the Ramrikawr down stream upto KAI LUI. Thence it follow KATLUI down streams upto its mouth to

The boundary description of the Dampa Wildlife Sanctuary will therefore stand as follows:-

NORTH

From the point where Kunda lui (stream) meets Tuilianpui river towards East following Kunda lui upstream and then takes its turn along with Tuivamit upstream and crosses the inter-village foot

path of Bunghmun and Serhmun villages upto its mouth to Sengmatawk lui (river). Thence, follows the Sengmatawk river downstream upto Teirei river.

EAST & : SOUTH

From the mouth of Sengmatawk river, the boundary follows Teirei river upstream upto the source and to the saddle where it meets Phaileng to Marpara road constructed by the Border Road Task Force. Thence it follows the said road and then along the said road towards south upto a small stream (Tuikhurlui) which comes out from Northern side of Vaisam tlang (Vaisam Peak). Then the boundary follows the said tuikhur lui upstream upto a point where the said Tuikhur lui crosses inter village footpath of Phuldungsei and Saithah. Thence it follows another stream (Thingthupui lui) towards west, downstream upto the mouth of Hmarluang stream. Thence follows Hmarluang lui upstream upto its source thence it crosses saddle towards south and goes down to Aivapui lui. Thence the boundary follows Aivapui lui downstream upto the mouth Kawilam lui (near Aivapui village). Thence the boundary follows upstream of Kawilam lui upto the mouth of Hmarluang lui. DUTIES AND FUNCTIONS

- 1. Simplify streamline and trationalise the functions of all organisation and agencies with thereto engaged in the investigation identification, promotion and management of small scale and village Industries in the selected of District of U.T. with the ultimate aim to cover all Districts in cause of time.
- 2. Formulate and ensure effective implementation of the District Industries Centres programme sponsored by Govt. of India in the various Districts of the Union Territory.
- 3. Initiate all activities concerning establishment of these District Industries Centres and advise the Union Territory Government as well as the Govt. of India regarding requirement of resources, personnel and infrastructural needs.
- 4. Select all staff provided for appointment in various D. I. Cs and ensure their appointment and replacement within the time schedule prescribed by Govt. of India.
- 5. Select sites, prepare building plans and ensure early creation of all physical facilities needed for smooth functioning of the District Industries Centres.

- 6. Provide quidelines to all District Industries Centres regarding "Work Programme" and accord approval to final plans prepared by them. In this regard, secure services of any suitable agency from inside or outside the Union Territory for timely achievement of the objectives.
- 7. Advise the Union Territory Government regarding the budgetting allocation from the Union Territory Plan and Non-Plan to be made in respect of various District Industries Centres, for effective utilisation of resources. Secure central assistance from various Boards, commissions, Financing Institutions, etc. for augmenting the resources in the U.T. Plan.
- 8. Review and monitor the programme of work undertaken by each District Industries Centre and evaluate specific economic and social gains derived out of the programme, furnish periodical reports on the above to the U.T. Government and Government of India.
- 9. Keep abreast of similar efforts being undertaken in various neighbouring States and Union Territories and disseminate the benefits thus derived, to the advantage of the District Industries Centre at Union Territories.

DURATION

The State Level Committee will remain in force for a period of two years from the date of issue of this notification or until further orders whichever is earlier.

FREQUENCY

The Committee should meet at least once in three months.

POWER TO CO-OPT

The chairman is authorised to co-opt any official expert of a Government of Quasi-Government organisation to the Committee for any specific meeting.

QUORUM

One-third of the total number of members including the Chairman will form the Quorum for any meetings of the Committee. A clear notice of 7 (seven) days should normally be issued for holding any meeting of the Committee.

TA/DA

Non-Official members will be entitled to TA/DA as admissible as Class I Officers and MLAs and MPs as admissible under Rules of the Mizoram salaries and Allowances as Members of the Legislative Assembly Act, 1973.

Subject: Illegal use of metal tokens as coinagelstoppage of.

Sir,

It has been reported that, taking advantage of the general shortage of small coins, some organisations/businesses are making and issuing metallic tokens to serve the place of coins in some parts of the country. The Reserve Bank of India have had the matter examined and the legal opinion obtained by them in this regard is reproduced below:—

- "Section 3 of the Metal Tokens Act, 1889 provides that no piece of copper or bronze or of any other metal or mixed metal which, whether stamped or unstamped is intended to be used as money shall be made except by the authority of Central Government. In terms of Section 2 of the said Act, 'issue' means to put a piece of metal into circulation for the first time for use as money. In case the token is circulated as money, then it would be an offence under the Metal Tokens Act. By virtue of Section 5 of the said Act, an offence of making metal token in contravention of Section 3 is a cognizable offence."
- 2. It will therefore be noted that if the Police could, on investigation into cases of possession of metal tokens, establish that they were intended to be put into circulation for use as money, prosecution could be launched against the parties concerned under the law as explained above.
- 3. You are, therefore, requested to bring to the notice of all concerned the above provisions of the Metal token Act, 1889 and issue instructions to the law in enforcing officers to be vigilant and to take strict action immediately whenever such activity is reported/detected in your State. It is further requested that if any such case is reported and action is taken in your State, a report may please be sent to this Ministry. Please acknowledge receipt of this letter.
