Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 65 of the Assam Cooperative Societies Act, 1949 (Act I of 1950) extended in Mizoram, I do hereby cancel the registration of the society. ş

Further, in exercise of the powers conferred by sub-section (i) of Section 66 of the Act I of 1950, I do hereby appoint Shri C. Chhawnzauva the Liquidator of Cooperative Societies, Aizawl District, Mizoram to be Liquidator of the said society.

All claims against the dissolved society must be submitted to the Liquidator within 2 months of the publication of this notice.
