- (v)To help allocation of and preparation of schemes for utilization of grants made available for various development works under Plan and Non-Plan and Centrally Sponsored programmes.

The Boards should meet as frequenty as possible, but at least once a quarter to discuss various development matters for implementing Plan and No-Plan schemes, to watch the progress monitor evaluate and to remove any deficiencies noticed during a particular period.

The proceeding of the meeting of the Boards should be forwarded to the Planning and Development Departments for information. The Planning and Development Departments will, whenever necessary, send relevant extracts to other Departments concerned for necessary action.
