JOINING TIME : Pay and TRANSFER TA : She will be entitled to TA and joining time both on joining the post on deputation and on reservation therefrom to the parent Government under the rules of Government from which she is deputed. The expenditure on this account will be borne by the borrrwoing Board.

6. T.A. FOR JOURNEY ON TOUR : During the period of deputation to be regulated under rules of Government from which she proceed on deputation.

7. LEAVE AND PENSION : During the period of deputation on temporary tranfer, she will continue to be governed by the leave and pension rule of the parent employer applicable to him before such transfer.

7. (A) PROVIDENT FUND BENEFITS : During the period of deputation she will continue to subscribe to the provident fund of his parent Govt. to which he may be subscribing when she is pleased on deputation, in accordance with the rule of such fund.

In the case of deputation of a Govt. servant who is governed by the contributory provident fund rules, Govt. contribution is payable by the Board to whom she is deputed for the period of her deputation.

7. (B) EXTRAORDINARY PENSION GRATUITY : This will be regulated in accordance with the Ministry of Finance (Department of Expenditure) O. M. No. F. 19 (23) E. V. (A)/64 dt. 2. 8. 1965.

8. LEAVE TRAVEL CONCESSIONS : She will continue to be entitled to leave travel concession under the MHA OM. No. 43/1/1955-Ests-II Pt. II dt. 11. 10. 1966 as amended from time to time and the cost thereof will be borne by the borrowing Board.

10. **RESIDENTIAL ACCOMMODATION** : She will be entitled to residential accommodation according to the rules of the Govt. from which she is deputed.

To free house or free will be allowed nor any conveyance will be provided at Govt. expense unless such benefits are normally attached as a condition of service to the post to which she is deputed.

ANNEXURE-I

NATIONAL YOUTH AWARD SCHEME

Young people in the country constitute a vast potential human resource which, if properly harnessed, can, greatly accelerate the process of national development. Recognition of young persons and voluntary organisations engaged in the field of youth work is particularly relevant for this purpose. This scheme of National Youth Award, therefore, aims to achieve this and in some measure.

OBJECTIVES :

2. The objectives of the national youth award scheme are :-
- i) to provide young persons between the age of 15-25 a challenge to achieve excellence in field of national or social service.
 - ii) to encourage young people to develop a sense of responsibility to their community and thus to improve their own personal potential as good citizens.
 - iii) to give recognition to the outstanding work done by young persons for national development and/or social service
 - iv) to give recognition to the outstanding work done by voluntary youth organisation for national development and/or social service.

NUMBER OF AWARDS :

3. The number of awards given each year would not exceed 50. As the objective of the scheme is to see that young persons achieve excellence in different fields of national or social service and also because in certain years, achievements in certain states might not measure upto achievements in other states, no particular number of award would be prescribed for each state/union territory. One youth award would be given to a voluntary organisation engaged in involvement of youth in various programmes of national development. The Central Selection Committee would decide as to whether all the 50 awards or a lesser number of awards are to be given.

FIELDS OF YOUTH WORK :

4. The fields of activities to be taken into consideration for the purpose of the national youth awards would include social work in the rural areas and urban slums, promotion of national integration, adventure, cultural and recreational activities, non formal and adult education programmes, work for improvement of the conditions of the persons belonging to the weaker section of the society, SC/ST and tribal areas, work connected with popularisation of the nationally accepted values; scouting and guiding and any other work considered important keeping in view the local needs and priorities. The state governments would identify priority areas and call upon their youth to concentrate their efforts in those fields.

CONDITIONS OF ELIGIBILITY :

5. (a) The youth to be recommended for the national youth award should satisfy the following conditions :-
- i) He/She should be between the age of 15-25 i.e. he/ she should have completed is to conferred and should be less than 25 years of age on the 31st of March of that financial year.

- ii) He/She should have rendered service in the relevant field during the financial year for which award is to be given and should also be the one who is likely to continue to involve himself/herself in such activities for at least another two years after the conferring of the award. For the financial year 1984-1985, however, performance for the period from 1.4.1984 to 30.6.1985 will be taken into consideration.
 - iii) The service rendered should be on a voluntary basis.
 - iv) The impact of the services rendered by him/her in person should be clearly identifiable, preferably quantitatively.
 - v) He/She should not have been conferred such an award earlier. Such of the persons who are recommended for the award once and are not finally selected, can, however, be recommended again.
 - vi) Officers of the Central/State Governments, Universities are not eligible for the award.
 - vii) Other considerations for guiding the selection of youth for the national award would include his/her reputation in the local community, his/her desire for improvement and genuine interest in the relevant field.
5. (b) The voluntary agencies to be eligible for the award should :-
- i) be registered under the Registration of Societies Act, 1860 (Act XXI 1860) or any corresponding State Act and have proper constitution or articles of association.
 - ii) have a properly constituted managing body with its powers and duties clearly defined in its constitution;
 - iii) be in a position to secure involvement on a voluntary basis, of knowledgeable persons for furtherance of its programmes;
 - iv) not be run for the profit of any individual or a body of individuals;
 - v) not discriminate against any person or group of persons on the ground of sex, religion, caste or creed;
 - vi) have rendered service in the relevant field for at least three years and should also be the one which is likely to remain engaged in the relevant field for at least another two years after the conferring of the award;
 - vii) not have been conferred such an award earlier (such of the agencies as are recommended for the award once and are not finally selected can, however, be recommended again) ;

- viii) have a good reputation in the local community ; and
- ix) the impact of the service rendered by it should be clearly identifiable, preferably quantitatively.

PROCEDURE FOR SELECTION :

6. The initial selection shall be made at the district level by a district committee from amongst the names recommended by the Universities/Colleges, local developmental departments, voluntary agencies and private bodies, public sector undertakings, Nehru Yavak Kendras etc. The Committees will be headed by the District Collector. The other members of the Committee could be representatives of the University; Nehru Yavak Kendra and voluntary agencies working in the field of youth. No voluntary agencies would, however be associated at the time of making recommendations of voluntary youth organisations for the National Youth Award. The recommendations made by the Committee would be considered by a State level committee under the Chairmanship of Chairman of the state Youth Board, wherever, these exist, and under the Chairmanship of the Department dealing with Youth Affairs in cases where the State Youth Boards do not exist. The composition of the State level committee will be decided by the State Government themselves.

The State level selecting committee shall scrutinise the recommendation of the District Committee and recommended to the Central Government at least 10 names of young persons who had shown excellence in youth activity or the other. The selection committees in Union Territory Administrations would recommend to the Central Government a panel of five names. The names of young persons selected by State/UT level committee shall be arranged in order of merit before they are recommended to the Central Government. Similarly, each State Government/UT Administration will recommend names of two voluntary agencies engaged in youth work arranged in order of merit. The recommendations of the State/UT. selection committee shall normally be accepted by the State/UT government. In case any variation is made, full justification for the same will have to be given.

At the Central level the National Youth Affairs Committee or a Sub-Committee of it will scrutinise recommendations of the State Governments/UT Administrations and make selection of youth awards.

AWARDS :

7. Each of the persons selected for the National Youth Award would be awarded a medal, a scroll and a cash award of Rs. 5,000/- for outstanding youth work. In the case of a voluntary youth organisation, the amount of cash award would be Rs. 1,00,000/-. The award giving ceremony would, ordinarily be held on the National Youth Day i.e. 12th January every year at New Delhi, for instance the award of the year 1984-1985 would be given on the 12th January 1986. The Young persons and the representative of the voluntary agency selected for the award would be given TA/DA by the first class return rail fare and arrangements

for their stay in Delhi would be made by the Department of Youth Affairs and Sports. As for award to the voluntary youth organisation, the award would be given to the institution.
