ORDER

No. B-17022/85-AGR(PT), the 27th May, 1986. Government of Mizoram have already introduced New Land Use Policy under the Rural Development Department for which all the Development Departments concerned have got to make their respective contribution to the tune of Rs. 3000/- (Rupees three thousand) per family per year for successful implementation of the scheme.

Now, it has been dicided also that all the Development Departments concerned will make every attempt to release whatever is possible in form of materials like rubber clones, Teak stumps, Coffee seedlings, etc. as per programme only from existing stock, nurseries etc. Whenever feasible; otherwise in cash as usual. The value of the materials supplied to each beneficiary will have to be calculated on the basis of approved rates for deduction from the overall of amount of Rs. 3000/- (Rupees three thousand) and the balance may be given in cash. It should be ensured that the beneficiaries attempt to acquire necessary materials, seedlings etc. by themselves in order to ensure maximum result within the limited resource.
