The Objects of the Fund are -

- (i) to award stipends to Ex-servicemen for technical, managerial, vocational or agricultural training at recognised training institutions;
- (ii) to sanction grants or loans to Co-operative societies or other associations of Ex-servicemen for schemes and projects of resettlement that is to say, horticulture, animal husbandary, Industry transport and the like;
- (iii) to sanction scholarships or grants to dependents of EX-SERVICEMEN UPTO THE MAXIMUM AGE OF 25 YEARS for higher studies in India beyond high school or higher (As amended) Secondary stage in technical, vocational or agricultural education at Government recognised institutes, the sanction of such courses of studies by the recipients;
- (iv) to sanction expenditure on special measures of a collective nature for the maintenance of old destitute Ex-servicemen of widows of Ex-servicemen.
- (v) to grant loans to individual Ex-servicemen for starting industries or business undertaking;
- (vi) to do all other things to promote measures for the benefit of Ex-servicemen and their dependents.
