Dear Shri Trivedi,

We have been considering the question of canstitution of Popular Committees at State, District and Block levels in the States/UTs, for some time past. This has been discussed in various fora by the Deputy Minister for Family Welfare and after due consideration it has been decided to constitute Popular Committee at State, District and Block levels. The principal objective of the scheme is to ensure adequate involvement of peoples representatives and other inportant groups besides key officials in these Committees to ensure greater Community participation and involvement of voluntary organisations. We also expect that operationalisation

of the scheme will streamline the process of planning, monitoring and implementation of the programme at all levels and coordination between various governmental agencies and departments, thus enabling us to generate and environment more conducive to the asceptance of the small family norm. I enclose a copy of the scheme proposed to be introduced along with this letter.

- 2. The Committee at State-level will be established by the State Government those at the district-level will be finalised by the State Government on the basis of the proposal received from the District Collector. The block-level committees are to be finalised by the District Collectors. We expect that you will be able to operationalise the scheme and constitute if the committee in your State latest by 31.8.1986.
- 3. No financial assistance will be available for State and Block-level committees. However, for the District level committees, a lump sum annual grant of Rs. 25.000/- will be provided for each district-level committee. We are separately releasing the amount for grants-in-aid for District-level committees in your State.
- 4. It has been decided that the scheme of Popular Committee, will be sanctioned for a period of 15 months from the date of issue of this order and its further continuance will depend upon the evaluation of the sheme to be carried out after 12 months.
- 5. I would request you to take immediate action to set up the committees and make them fully operational. A report confirming constitution of the committee at various levels may please be sent to this Vinistry by the 8th September, 1986.

SCHEME FOR THE CONSTITUTION OF POPULAR COMMITTEE

No.V-16011/6/85-Ply. Inputs Required: It has been decided to provide assistance only to the District level Committees and not to the State and Block level Committees. Whereas expenditure on State I evel Committee are to be borne by the State Governments/U.Ts themselves, the District level Committees because of their crucial importance in both planning and implementation of the programme are to be given assistance to ensure mobility and basic minimum facilities for an office. The Block level Committees are to be constituted by the State Government and no as sistance will be provided for these committees by the Government of India.

It has been decided to provide an annual lump sum grant of Rs, 25,000/- to the District level Committees. A vehicle will be made available by the District Collector/District Medical Officer from the District pool for use of the Committee for touring, motivation and other related purposes. The annual grant will be spent at the discretion of the Chairman of the District level Committee for the following purposes:

(a) POL for the vehicle.
(b) Rent for office space.

(c) Furniture for office.

(d) TA/DA to non-officials and other Contingencies for meetings.

(e) Motivational work or other work directly in connection with the F.W. programme implementation or monitoring of the programme.

FUNCTION OF THE COMMITTEES

The major functions of the District level will be as follows.

- B. District level Committee:
- 1. The District level Committee will draw up a perspective plan for Family Welfare pragramme including MCH and Immunisation

 District for the remaining four years of the 7th Plan and Annual and Quarterly Action Plans. These Plans will set out the goals to be achieved, the strategies to be adopted and spell out the detailed activities and responsibilities of various Department and levels of officials. The plans will set out specific time-frames within which the activities have to be carried out and also a detailed mechanism for monitoring the progress of the activities. This Committee will also continuously plan and monitor the programme implementation and performance in the district.
- 2. The Committee will assign the targets to be achieved by the Block and various functions to other officials of the district and lower levels.
- 3. The Committee members will undertake tours to organise/inspect the camps and functioning of fan.

 They will be provided a vehicle by the District Callector/District Medical Officer for this purpose out of the district pool.
- 4. This Committee will meet once every month formally and will be provided office space and furniture etc. to held meetings/discussions etc.
- 5. The Committee will endure coordination among functionaries of related department/agencies and see that they function in an integrated manner in implementation of their programmes at the grass-root level. This would include inter-alia, functionaries/officials of Education, Social Welfare, Labour, Cooperatives, Agriculture, Rural Development Departments.

- 6. The Committee will ensure involvement of people's representatives, non-officials non-governmental organisations in an effective manner and also mobilise popular support for the programme through involvement of community leaders.
- 7. The Committee will assess the performance of all the blocks and provide guidance, assistance and additional support wherever necessary.
