#### ORDER

No. D. 32020/13/85-HMP/Pt/II: the 5th March 1987 Whereas there has been an incident of mob violence at Saitual, Aizawl, on 1st March 1987 due to rioting between some local people and Border Road Workers as a result of which 9 persons died and another 17 persons sustained injuries.

And whereas the Governor, Mizoram, considers that an enquiry should be made to ascertain the facts and circumstances which led to this unfortunate incident and also the persons responsible for the said incident.

Now therefore the Governor of Mizoram appoints Shri. D. Purkayastha. Additional District, Magistrate Aizawl District to enquire into the incident and all other matters related thereto with particular reference to:

a) The cause of the incident;

b) The failure or omission, if any of the village administration, and Police and;

c) The steps to be taken to prevent recurrence of such incident in future.

The report should be submitted within two weeks from this order.
