## A N N E X U R E BOUNDARY DESCRIPTION OF KHAWHAI FOREST RANGE UNDER CHAMPHAI FOREST DIVISION

Headquarters: Khawhai

EAST: Starting from the Inter Division Boundary of Champhai and N. Vanlaiphai Forest Divisions the boundary runs towards North-East following River Tuipui upstream till it reaches inter villages boundary between Vengthlang and Tualte Villages.

NORTH: Starting from River Tuipui it runs along the inter village boundary of Vangtlang and Tualte villages and crosses Khawzawl-Khawhai Public Works Department Road till it reaches Phaisen Lui and thence follows Phaisen Lui downstream till it Reaches R. Tuichang.

WEST: From the meeting point it runs along the R. Tuichang and thence follows inter Division boundary of Champhai and N. Vanlaiphai till it reaches Sialhawk

SOUTH: From Sialhawk it follows inter Division boundary along the existing Public Works Department Road upto Biate from where it meets the starting point at R. Tuipui.

- 7. To consider linkages/in consultation with banks, financial institutional and marketing agencies.
- 8. To review the periodical reports, returns and achievements and ensure submission of periodical reports of achievement to the Ministry of Agriculture, Department of Agriculture & Co-operation, Shastri Bhavan New Delhi and Department of Rural Development, Krishi Bhavan, New Delhi as well as to the Adviser (State Plans), Planning Commission, New Delhi on time.
- 9. To prepare comprehensive project document. Annual Action Plan and submit to the Government of India and provide guidance to the line Officers for preparation of district level, block level plans.
- 10. Determine and draw up long terms and short term projects.
- 11. To prepare a programme book which will contain calender of works in English and local language and also a literature in simple English and local language.
