(c) Pocket money : Rs. 150/- per annum.

(d) Caution money : Rs. 150/- should be refunded the Govi. on completion of course of study in the school and the amount is to be give only during the first year.

(c) Journey expenses from home to school and back the time of initial admission and subsequently for coming home and return to school during authorised school vacation, actual second class railway and bus fare plus Rs. 10/- per day will be given for to journey twice a year-"

- No.B. 11013/24/81-P&AR (C) the 25th June. 1987: Subject to the conditions specified in paragraphs 2 & 3, the Governor of Mizoram is pleased to grant defecto/Informal Recognition to Mizoram Economics and Statistical Services Association with effect from the date of publication of this Notification in the Mizoram Official Gazette.
- 2. CONDITION SUBJECT TO WHICH RECOGNITION IS GRANTED:
 The Mizoram Economics and Statistical Services Association recognised herein shall comply with the following conditions:—
- 1. The Primary object of the Association/Union shall be the promotion of the common Service interest of its members.
- 2. The Association/Union shall not be based on any caste, tribe or religious denomination or on any group within or section of such caste, tribe or religious denomination.
- 3. The Association/Union should have as its members, not less than 15% of the total number of staff of each category/categories it purports to represent.
- 4. No person who is not a Govt, servant shall be connected with the affairs of the Association/Union.

- 5. The executive of the Association/Union shall be appointed from amongst the members only.
- 6. The funds of the service Association/Union shall consist exclusively of subscriptions from members and grants, if any, made by the Govt. and shall be applied only for the furtherance of the objects of the Association/Union.
- 7. The Association/Union shall not send any representation or deputation except in connection with a matter which is of common interest to the members of the Association/Union.
- 8. The Association/Union shall not expause/or support the cause of individual Govt. servants relating to service matters.
- 9. The Association/Union shall not maintain any political fund or lend itself to the propagation of the views of any political party of politician.
- 10. All representations by the Association/Union shall be submitted through proper channel, and shall, as a normal practice, be addressed to the Secretary or the Head of Department or Office.
- 11. A list of members and office bearers, and up-to-date copy of the rules and an audit statement of accounts of the Association/Union shall be furnished to the Govt. annually through proper channel after the general annual meeting so as to reach the Govt for information.
- 12. Any amendment of a substantial character in the rules of the Association/ Union shall be made only with the previous approvals of Govt. and any other amendment of a minor importance shall be communicated through proper channel for transmission to the Govt. for information.
- 13. The precious permission of the Govt. shall be taken before the Association/Union seeks affiliation with any other Union, Service Association or Federation.
- 14. The Association/Union shall cease to be affiliated to a Federation or Confederation of Service Associations whose recognition is withdrawn by the Government.
- 15. The Association/Union shall not start or published any periodical magazine or bulletin without the previous approval of the Government.
- 16. The Association/Union shall cease to publish any periodical magazine or bulleting, if directed by the Govt. to do so on the ground that the publication thereof is prejudicial to the interests of the Central Govt. the Govt. of any State or any Govt. or any Govt. authority.
- 17. The Association/Union shall not do any act or assist in the doing of any act which, if done by a Govt. servant, would contravence any of the provisions of Rules, 8,9,11.12,16 & 20 of the Central Civil Services (conduct) rules, 1964.

- 18. The Association/Union shall not address communication to a foreign authority accept through the Govt, which shall have the right to vishbold it; and
- 19. The ecommunications addressed by the Association/Union, or by any office-bearer on its behalf to the Govt. or a Govt. sutherity shall not contain any disrespectful or improper language.

Subject: Enhancement of the rate of stipend/Book Grant awarded to students prosecuting various technical courses of studies.

The question of enhancement of the rate of stipend/Book Grant awarded to students prosecuting various technical courses of studies has been under consideration of the Government for some time past. It has now been decided to enhance the existing rates of sigend and Book Grant awarded to Mizoram Government sponsored students of various technical courses of studies with effect from 1.4.1987 as under ;—

Uniform allowances to General Nursing and Mid Wifery is also enhanced from Rs. 150/-p.a. to Rs. 300/-p.a.

2. In respect of Post Graduate Students who are getting stipend from the Institution where they are studying, the Mizoram Government will have to pay only the shortfall amount in order to bring the total stipend to Rs. 1000/-pm.

- 3. The existing norm of payment for study tours of actual expenses limited to Rs. 200/- per annum has been dispensed with. Other conditions remaining unchanged, payment to be made for study tours on the basis of actual expenditure incurred by the students as certified by the Head of the Institutions.
- 4. The Additional requirement of fund due to enhancement of rates of stipend and Book Giants will have to be arranged at the time of Revised Budget Estimates by all concerned Department. Rules governing grant of stipend etc. to the students sponsored by Government of Mizoram will be issued in due course.
