#### 2. Condition subject to which recognition is granted:

The Mizoram Non-Gazetted Forest Service Association recognised herein shall comply with the following conditions:-

- i) The Primary object of the Association shall be the promotion of the common service interest of its members.
- ii) The Association shall not be based on any caste, tribe or religious denomination or on any group within or section of such caste, tribe or religious denomination.
- iii) The Association should have as its members, not less than 15% of the total number of staff of each category/categories it purports to represent.
- iv) No person who is not a Govt. servant shall be connected with the affairs of the Association.
- v) The executive of the Association shall be  $\epsilon$  ppointed from amongst the members only.
- vi) The funds of the service Association shall consist exclusively of subcriptions from members and grants, if any, made by the Govt. and shall be applied only for the furtherance of the objects of the Association.
- vii) The Association shall not send any representation or deputation except in connection with a matter which is of common interest to the members of the Association.
- viii) The ssociation shall not e pouse/or suppor the cause of individual Govt. servants relating to Service matters.
- ix) The Association shall not maintain any political fund or lend itself to the propagation of the views of any political party of politician.
- x) All representations by the Association shall be submitted through proper channel, and shall, as a normal practice, be addressed to the Secretary or the Head of Department or office.

- xi) A list of members and office bearers, and up-to-date copy of the rules and an audited statement of accounts of the Association shall be furnished to the Govt. annually through proper channel after the general annual meeting so as to reach the Govt. before the 1st day of July each year.
- xii) Any amendment of a substantial character in the rules of the Association shall be made only with the previous approval of Govt., and any other amendment of a minor importance shall be communicated through proper channel for transmission to the Govt. for information.
- xiii) The previous permission of the Govt. shall be taken before the Association seeks affiliation with any other Service Association or Federation.
- xiv) The Association shall cease to be affiliated to a federation or Confederation of Service Associations whose recognition is withdrawn by the Government.
- xv) The Association shall not start or published any periodical magazine or bulleting without the previous approval of the Government.
- xvi) The Association shall cease to publish any periodical magazine or bulletins, if directed by the Govt. to do so on the ground that the publication thereof is prejudicial to the interests of the Central Govt., the Govt. of any State or any Govt. authority or to good relations between Govt servants and the Govt. or any Govt. authority.
- xvii) The Association shall not do any act or assist in the doing of any act which, if done by a Govt. servant, would contravence any of the provisions of Rules, 8, 9, 11, 12, 16 & 20 of the Central Civil Services (conduct) Rules, 1964.
- xviii) The Association shall not address any communication to a foreign authority except through the Govt. which shall have the right to withhold it; and
- xix) The communications addressed by the Association or by any office bearer on its behalf to the Govt. authority shall not contain any disrespectful or improper language.
- 3. WITHDRAWAL OF RECOGNITION: If, in the opinion of the Governor of the State of Mizoram Non-Gazetted Forest Service Association herein fails to comply with the conditions set out at para 2 above, the Governor may withdraw this recognition at anytime.
