The Headquarters of this newly created Soil Conservation Division is at Hnahthial and that of the New Soil Conservation Ranges will be at South Vanlaiphai and Thingsai respectively.

The boundary of new Soil Conservation Division at Hnahthial is as follows:

Northernside: Inter District boundary of Aizawl District and Lunglei District.

Easternside: Along the Tiau river which its international boundary of India

and Burma.

Southernside: Along the Darzo river which is inter District boundary of Lung-

lei and Chhimtuipui Districts.

Westernside: It starts from the junction of Aizawl, Lunglei Inter-District

boundary and Tlawng river in the north. Then follows along the Tlawng river and goes upto North of Khankawn (z) Village and meets Mat river. Then the boundary follows along the Mat

river upto the junction of Mat river and Darzo river.

The boundary of the Soil Conservation Ranges is as follows:

#### SOUTH VANLAIPHAI SOIL CONSERVATION RANGE.

The Western and Northernside of the boundary line will follow the Tuipui river. In the eastern and Southern side the boundary line will follow the inter-District boundary of Lunglei and Chhimtuipui Districts.

## 2. THINGSAI SOIL CONSERVATION RANGE:

In the Northernside, the boundary will follow along the inter Districts boundary of Aizawl and Lunglei District. In the Westernside the boundary line will follow along the Tuichang River till it meets Tuipui River. In the Southernside the boundary line starts from the junction of Tiau River and inter District boundary of Lunglei and Chhimtuipui District then follows along the Tuipui River direction till it meet Tuipang River. In the Easternside the boundary follows along Tiau River.

# 3. HNAHTHIAL SOIL CONSERVATION RANGE (Existing Range)

The area and boundary will be in between the three rivers of Mat, Tuichang and Tuipui in the East and West, in the Northernside, the boundary will be along the Inter District boundary of Aizawl and Lunglei Districts. And in the Southernside the boundary line will follow along the Mat River and Inter District boundary of Lunglei and Chhimtuipui Districts.

# 4. HAULAWNG SOIL CONSERVATION RANGE (Existing Range)

The area and boundary will be in between two Rivers Tlawng and Mat Rivers in the West and East. In the North and South the boundary area will be the Hnahthial Soil Conservation Division boundary.
