The Governor of Mizoram is pleased to order creation of a new Agriculture District at Kolasib and 2(two) new Agriculture Sub-Divisions at Bilkhawthlir and Zawlnuam. The existing Agriculture Sub-Division at Kolasib will function as Sadar Sub-Division under Agriculture Department Government of Mizoram.

The jurisdiction and boundary of the newly created Kolasib Agriculture District and Agriculture Sub-Divisions are as follows:

#### 1. KOLASIB AGRICULTURE DISTRICT.

Headquarter — Kolasib.

JURISDICTION: The jurisdiction of the Kolasib Agriculture District Comprises of Northern part of Aizawl West Agriculture District covering Thingdawl Block and Northern part of Zawlnuam Block as defined in the Kolasib Agriculture District boundary.

#### **BOUNDARY DESCRIPTION:**

NORTH: Starting from the West, the boundary on the north will run towards the east along the inter-state boundary of Assam and Mizoram upto the point where Tuirial river crosses the inter-state boundary.

EAST: Starting from the north, the boundary on the east will run along the Tuirial river up to the Village boundary between Serkhan and Lungdai.

SOUTH: Starting from the east at the confluence of Puansimlui, the boundary on the South will follow the Village boundary between Serkhan and Lungdai and runs westernly along the village boundary between Sentlang and Serkhan and follows Pualhranglui upto the Confluence at Tlawng river. Then runs along Tlawng river upto the confluence at Tut river. And thence runs western y along the inter-Village boundary between Vangawn and N. Sabual and crosses Teirei river and runs along the inter-village boundary between Rengdil and Kawrthah right upto Langkaih (inter-state boundary of Mizoram and Tripura)

WEST: Starting from the south at Rengdil village jurisdiction, the boundary on the west follows northernly along the inter-state boundary of Mizoram and Tripura and meets the starting points of the boundary on the north.

#### 2. BILKHAWTHLIR AGRICULTURE SUB-DIVISION

Headquarter — Bilkhawthlir.

Bilkhawthlir Sub-Division will comprise the villages under Bilkhawthlir Agriculture Circle and N. Hlimen Agriculture Circle.

#### **BOUNDARY DESCRIPTION**

EAST: Starting from the inter-state boundary of Assam and Mizoram it will follow Tuirial river towards the upto the boundary line of Saipum and N. Hlimen.

SOUTH: From Tuirial river it will follow down the boundary line of Saipum and N. Hlimen, crosses Serlui and Chemlui rivers and Aizawl-Silchar Road in between Kolasib and Bilkhawthlir along Kolasib and inter-village boundary and meets Assam border including Buhchangphai and Phaisen.

WEST: From Buhchangphai in the South it follows up Assam Mizoram border upto Vairengte.

NORTH: From Buhchangphai in the south it follows Assam-Mizoram border till it meets Tuirial river beyond Saipum.

#### ZAWLNUAM AGRICULTURE SUB-DIVISION

Headquarter — Zawlnuam

Zawlnuam Agriculture Sub-Division will Comprise all the villages under the Zawlnuam (Lokicherra) Agriculture circle.

EAST: Starting from Bairabi in the North it will go along Tlawng river till it meets the confluence point with Tlawng river.

SOUTH: From the confluence point of Tlawng river it goes, straight towards the west following Rengdil and Kawrthah inter-village boundary till it meets Mizoram Tripura border.
