**AMENDMENT TO RULES FOR MIZO STUDENTS' HOSTEL AT SHILLONG.**

Substitute the existing Rule by the following :

**Rule 5 —** The Superintendent of each hostel shall be paid a monthly honorarium of Rs. 200/- (Rupees two hundred) only plus house rent of Rs. 200/- (Rupees two hundred) only per month.

**Rule 12 —** Boarders taking admission in the Hostels shall pay the following Hostel dues :-

- (a) Admission fee @ Rs. 30/- (payable every session)
- (b) Establishments fee @ Rs. 20/- (payable on 1st admission)
- (c) Caution money @ Rs. 100/- (Refundable at the end of the session if not deducted as per Rules).
- (d) Seat-rent @ Rs. 100/- (per session)
- (e) Medical fee @ Rs. 10/- (payable for every session).
- (f) Game fee @ Rs. 20/- (per annum).
