Whereas vide notification No.A. 12018/2/82-HMP Dated 26th September 1986, Matriculation from recognised University or H.S.L.C from any recognised Board of School or Board of Higher Secondary Education has been prescribed as the minimum educational qualification for recruitment of constable in police Department.

And whereas it is not possible to get immediately sufficient number of persons with aforesaid qualifications for appointment as constables.

Now, therefore, in excercise of the powers under section 2 of the Police Act, 1861, the Governor of Mizoram, is pleased to direct that not withstanding the qualifications prescribed vide notification No. A. 12018/3/82-HMP Dated 26th September 1986, the minimum qualification for the recruitment of constables in Police Department will be class VIII standard.

The Governor of Mizoram is further pleased to direct that this relaxation shall be in force for a period of six months from the date of issue of this notification.
