In exercise of the powers conferred under Rule 20 of Delegation of Financial Power Rules, 1978. the Governor of Mizoram is pleased, to make Regulations to regulate the award of Research Fellowship stipends/scholarships for talented students of the State of Mizoram as follows

1. SHORT TITLE and COMMENCEMENT:

- (a) These rules may be called the Mizoram Research Fellowship Regulations 1988.
- (b) They shall come into force at once.

2. DEFINITIONS

In this Regulation unless the context otherwise requires;

- (a) "Awarding authority" means The Selection Board constituted by the Government.
- (b) "Director" means Director of Education Mizoram.
- (c) "Examination" means Examination conducted by any recognised University or Institution in India
- (d) "Gazette" means The Mizotam Gazette.
- (e) "Government" means the Government of Mizoram.
- (f) "Mizoram" means the State of Mizoram.
- (g) "Years" means an academic year.

3. CATEGORIES OF FELLO VSHIP:

The Fellowship Programme of the Mizoram will cover two categories:

- (a) Fellowship for College teachers doing research in India.
- (b) Fellowship for College workers doing research in India.

VALUE:

There shall be Junior and Senior Research Fellowship:

- (a) The Junior Fellowship shall be Rs. 900/- per month and will normally be awarded initially for one year for research leading to Master of Philosophy (M. Phil) and extendable in exceptional deserving case by one year.
- (b) The Senior Research Fellowship shall be Rs. 1130/- per month. A Research Fellow who has one year undertaking research and has been receiving Junior Research Followship may be awarded the Senior Research Fellowship leading to the Doctor of Philosophy (Ph. D) if the work done by him is found to be satisfactory after due assessment.

5. CONTINGENT GRANT:

In addition to the Fellowship grants, Salary and allowances, etc., the Research Fellowship carries a contingent grant of Rs. 5000/- for approved contingent expenditure on such items as travelling allowance

- (e) The selected candidate for Mizoram Research Fellowship award shall submit his/her acceptance of the award within one month of issue of the selected names for the said award by the awarding authority. Failure to submit acceptance of the award the scheduled period, the award is liable to be cancelled.
- 16. The above rules apply also to travel grant or contingent grant without fellowship in connection with doctoral and post-doctorla.

17 LIABILITY FOR REFUND:

In the event of an awardee abandoning his studies of research at any stage without sufficient justification acceptable to the awarding authority the award shall be cancelled and the full amount of the award already paid shall be liable to refund by the awardee.

- (b) The amount of the fellowship shall be payable from the office of the Director who shall have the proposal for sanction made to the Government and the sanction money drawn for payment to the awardees through the respective Head of institution/University. The amount shall be paid to the institution in advance in six-monthly instalment.
- (c) The institution shall provide to the fellow facilities of accommodation, including furniture, library and research facilities and messenger service. For this, the awarding authority shall pay to the institution overhead charges to five percent of the grant-in-aid sanctioned under these Rules. The amount of these overhead charges shall be paid after the conclusion of the fel owship and the receipt of audited statement of accounts and utilisation certificate.

13. PROGRESS KEPORT :

The research fellow shall submit a six monthly progress report to the institution which shall forward it to the awarding authority along with a statement of expenditure during the proceeding six months and an estimate of the expenditure likely to be incurred during the next six months. The subsequent instalment will be released only on receipt of these documents. In case of failure to submit the progress report, the awardees is liable to lose his/her fellowship grant without any further notice.

14. FINAL REPORT:

On conclusion of the fellowship, and in any case not later that six months thereafter, the research fellow shall submit a complate copy of his work with an abstract incorporating the main conclusions reached by him.

15. OTHER CONDITIONS:

- (a) A research fellow shall engage himself on his research work on a wholetime basis and shall not except, during the period of fellowship, any other assignment, (with or without payment) without the prior permission of the awarding authority.
- (b) Unless the awarding authority decides otherwise, all equipments purchased out of the contingent grant shall be transfered to it after the completion of the work. The books purchased upto a limit of Rs. 1000/-(Rupees one thousand) only out of the funds of the contingent may be retained by the scholar concerned.
- (c) The awarding authority may terminate fellowship after giving one month's notice, if it is of the view that the progress is not satisfactory and that the research fellow has seriously violated the rules and conditions of the fellowship.
- (d) After completion of the research work, all the Mizoram Research Fellowship awardees must submit a copy of their respective research paper/dessertation/thesis to the awarding authority.

9. **SELECTION**:

- (a) A research scholar eligible under the above rule may apply for a research fellowship in the prescribed form in the Annexure I & II through the institution where he/she is working submitting copy of detailed note/synopsis on his/her research and his/her/bio-data to the Director of Education Mizeram within the prescribe date.
- (b) The application shall be considered by the awarding authority in accordance with such procedures as may be laid down from time to time and research followship will be awarded if the authority considered the applicant to be eligible and approves of his research proposal.
- (c) The name of the selected candidates shall be published by Notification in the Gazette with intimation to the candidates so selected. Acceptance of the award on the part of the candidates shall be made within one month from the date of intimation failing which the selection shall be liable to cancellation.

10. NUMBER:

Normally not more than 20 (twenty) Research Fellowships may be awarded a fresh in any academic year. The fellowship should be distributed as far as possible to different faculty subjects or fields in equal numbers. The numbers of awards shall be decided each year by the awarding authority.

11. REMUNERATION:

During the term of full-time fellowship, the teacher fellow shall receive the same salary as he was drawing before the award, if he is on employee of a University or a teaching or research institution. If he is in the service/college/ research institution his status shall be equated and the salary payable to him shall be fixed accordingly. By any means, his total salary during the period of fellowship does not exceed drawn by him prior to taking up the fellowship. The fellow will be entitled to the allowances admissible in the institution of affiliation.

12. INSTITUTIONAL AFFILIATION:

(a) Every research fellow shall be attached to an institution of his choice and approved by the awarding authority through which the fellowship amount shall be disbursed. During the period of such attachements, the research fellow shall be treated as an employee or a student of the institution for all administrative purposes and then rules of the institution shall apply in the matter of the drawal of travelling allowances and daily allowances, holiday and contingent expenditure. It should be clearly understood that the fellowship is no in the nature of deputation and not liability will be attached to the awarding authority or to the institution concerned for payment of any contribution towards leave salary, pension, medical attendance, etc.

and daily allowance for journeys in connection with the persuit of the fellow-ship, purchase of books, Secretariat assistance, stationery, etc. Those who will be doing part time research work in addition to their existing duties shall also be given such a contingent grant. In no case not more than ten contingent grants shall be provided to part time research workers annually.

This contingent grant of Rs. 5000/- shall be subject to the production of proper utilisation certificates as may be required by the awarding authority.

6. SCOPE AND TENABITY:

The Research Fellowship is intended for research workers and teachers preferably below the age of 45 years who have established their reputation for research or who in any field, and who have obtained a doctorate degree have published research work to their credit and have already shown evidence of independent research work.

7. CONDITION OF ELIGIBILITY:

- (a) Only the children or wards of Bonafied permanent residents of Mizoram shall be eligible for the award of fellowship for which application will be made in the form as in the Annexure to these Regulations.
- (b) No student proceduting higher studies or research under any University or institution which is not recognised or established by law shall be eligible for the award of fellowship.
- (c) No student found quilty of misconduct of breach of discipline or participating in strikes, demonstrations, picketings and the like for unfair demands from any rightful authority shall be eligible for the award of fellowship under these Regulations.
- (d) No student who fails to secure at least 50 percent marks on an average in the last University Examination shall be eligible for the award, unless otherwise relaxed by the awarding authority.
- (e) A student who has availed himself of the award once for subject or failed of research shall not be eligible for a second or another award under these Regulations.
- (f) A student/research fellow in receipt of any scholarship or stipend, except merit scholarship, from any source shall not be eligible for award under these Regulations
- 8. The duration of the research fellowship shall normally be one year for Master of Phylosophy (M. Phil) and two years for Doctoral candidates and one year for post-Doctoral, each extendable in exceptional and deserving cases by one year. A detailed review of the work done will be made at the end of each year and further continuance of the fellowship will be decided thereupon. The total duration of Junior Fellow Research Fellowship and Senior Research Fellowship taken together shall not in any case exceed five years.
