Under this programme, one time cost of internal wiring and service connection charges, upto a maximum of Rs. 200/-per connection (which is exclusive of all charges including supervision charges of P&E Deptt. and nominal service charge of REC) would be provided by way of grant to Rural Electrification Corporation through State Govt. to the Deptt. of Power & Electricity which will be the executing Department. This capital cost will not be recovered from the beneficiaries.

During the 88-89, 1000 families in 39 villages (Aizawl Dist. 23, Lunglei 12, Chhimitupui Dist. 4 villages) of Mizoram living below the poverty line are to be provided such connections.
