Handloom cloth and Weaver cloth have been include under the reserve items of Schedule I of the said Rules and purchases of items covered by Schedule I are to be made only from registered industries in terms of Clause 7 (i) of the Preferential Store Purchase Rules. The Rules applicable in respect of all the purchase of stores, to be made by the departments, institutions' agencies, corporations, undertakings etc. of the Government.

- The Government of Mizoram has now decided that only handloom materials produced by local registered weavers should be used for curtains in all Government offices, Rest Houses/Inspection Bunglows, institutions, Government residential Quarters, agencies, undertakings and corporations of the Govt. of Mizoram. Local handloom fabrics should also be used for bed sheets, bed covers and patients' dresses in hospitals, PHCs and dispensaries.
- 3. The Government further decided to appoint the following to function as canalising agencies:—
 - 1. Mizoram Apex Handloom and Handicraft Cooperative Society (MAHCO).
 - 2. Mizoram Khadi & Village Industries Board.
 - 3. Industries Sales Emporium, Aizawl/Lunglei.
 - 4. Raw Materials Depot, Aizawl.
 - 5. Branch Raw Material Depot-Lunglei/Saiha/Serchhip/Champhai.

- 4. The above agencies will procure the handloom fabrics directly from the weavers. Government Department's and other institutions/undertakings reguiring the materials will purchase the same from these agencies.
- 5.
