The Government of Mizoram have taken note of the fact that large number of foreigners take shelter inside Mizoram and some of them are trying to merge with the local people. There are also reports that certain sections may try to make Mizoram as a base for insurgency movement. Criminals and drug smugglers take advantage of the present situation and as a result, there has been an increase in drug trafficking in the recent past.

In view of the aforesaid circumstance, it is hereby ordered that owners of residential houses, shops, buildings and other premises should report immediately to the concerned Deputy Commissioner Supdt of Police, SDO (Civil) and SDPO, the names and other details of all the persons believed to be foreigners staying in their houses or premises as tenants or otherwise such as domestic helpers, employees etc. in the proforma at appendix, Such information should be furnished positively within one month from the date of this Notification and failure to give the required information within the stipulated time will be punishable under relevant provisions of law.

It should be noted by all concerned that ethnic affinity with Mizo community alone does not make a man an Indian citizen and the place of birth, permanent residence and length of time already spent in Mizoram will be some of the indicators to determine who is a foreigner. In case any doubt is entertained by the owners of houses and other premises regarding the citizenship of a particular individual, such a case shall be referred to the concerned Deputy Commissioner for decision.
