As decided by the Govt. of Mizoram vide No. D. 29017/3/89--DTE(P&S) dt. 2.8.89 the following system will be adapted in the publication of Mizoram Gazette henceforth.

A N N E X U R E—I

THE MIZORAM GAZETTE (GENERAL OR REGULAR)

There will be 11 (eleven) parts of the Mizoram Gazette which is to be published combinedly on every Friday of every week. The parts are as follows :—

1. PART I : Notifications relating to Promotions, Appointments, Posting Transfers, Powers, Leave, Deputation, Disposal, taking over charges, lien, change of Headquarters etc.
2. PART II(A) : Resolutions, Regulation, Orders, Notifications, Recruitment Rules (if not specifically mentioned extra ordinary) Rules and Acts, Award of Tribunal, Requisition, Acquisition and declaration relating to land and Forest etc., by the State Govt. and Head of Departments. Also statutory orders and notifications issued by Head of Departments and the State Govt.
3. PART II(B) : Order, Notifications and Rules of High Court of Assam, Nagaland, Meghalaya, Mizoram, Tripura and Arunachal Pradesh.
4. PART III : Orders, Notifications and Rules of Govt. of India by the Election Commission of India, Papers extracted from the Gazette of India and other State Government relating to Election.

5. PART IV : Acts of Legislative Assembly of Mizoram and Ordinance promulgated by the Governor of Mizoram.
6. PART V : Bills introduced in Mizoram Legislative Assembly. Also reports of any Commission/statutory committee etc.
7. PART VI : Proceedings of the Mizoram Legislative Assembly.
8. PART VII : Acts of Parliament and Ordinance promulgated by the President.
9. PART VIII : Bills introduced in Parliament.
10. PART IX : Advertisements, Notices (Tender Notices, Advertisements for the post and vacancies etc) Registration and Liquidation and Merger Notification of Co-Operative Societies by the State Government, Results of the State Lottery. Also private notices are also published on payment.
11. PART X ALSO (or Supplement) (Autonomous District Councils) Order, Notifications, Resolutions, etc given by Autonomous District Councils. These parts have separate page numbering which at start from 1st January of every Calendar Year. The above all parts are published combinedly in one book in every Friday of every Week.

THE MIZORAM GAZETTE (EXTRA ORDINARY)

This has no definite date or day. It is to be published as and when important Notification is sent by the Government to publish as Extraordinary Gazette and will be published at the same date if the matter to be printed is upto 2 pages of type written matter and over 2 pages and upto eight pages the printing time will take 48 hours.

To publish in an Extraordinary Gazette, the Law Department, Finance Department and Legislative Assembly Secretariat can issue Notification directly. The other Department should take approval of Chief Secretary or Secretary, Printing and Stationery Department. They cannot issue a Notification in extraordinary Gazette directly.

The Chairman of the Board may co-opt any other person/persons as special invitees for any of the meetings of the Boards.

Members of Parliament and Mizoram Legislative Assembly who are included as members will cease to be members as and when they vacate their Office.

The functions of the District Planning and Development Boards will be as follows :—

- (i) To prepare District Annual and Five Year Plans in relation to the needs of the District in the month of May every year or as and when necessary for admission to the Department concerned.
- (ii) To review, monitor and evaluate the progress of various development schemes implemented by different departments within the District from time to time on the basis of quarterly reports submitted by the local heads of District Offices and submit consolidated quarterly reports of the district.

(iii) To advise on integrated implementation of plans, addicent utilisation of funds allotted and to suggest priorities for expenditure within the sum allotted by the Government, in particular, to recommend measures for effective fillment of schemes of economic and social developments and more especially of Community Development Blocks, Agricultural production programmes, social services and small industries.

(iv) To promote public perticipation and cooperation in development programmes, and expand local community efforts both in urban and rural areas.

(v) To held allocation of and preparation of schemes for uttilisation of grants made available for various development works under Plan and Non-Plan and Centrally Sponsored Programmes.

The Boards should meet as frequently as possible, cut at least once in a quarter.

The proceeding of the meeting of the Boards should be forwarded to the planning & Programme Implementation Department of the Government as well as State Planning Boards for Information and necessary action. The Planning & Programme implementation Department may wherever necessary send relevant extracts to other Departments concerned for necessary action.
