(1) These Rules may be called the Mizoram Post Matric Merat Science Scholarship Rules 1989.

- (2) They shall come into force with immediate effect.
- 2. RATE OF SCHOLARSHIP :--

The following rate of scholarship shall be awarded to Science students as mentioned below :---

(2) In addition to the Scholarship, the fees charged by the College/University for each student will be met by the Government.

2. ELIGIBILITY FOR GRANT OF SCHOLARSHIP :—

Only students who are Mizos belonging to Mizoram will be eligible for the award.

(2) Selection will be done strictly on merit basis. Criteria for evaluation will be based on the performance of the candidate in the concerned subjects in the last examination provided the candidate secured pass marks in other subjects.

(3) Selected students should execute an undertaking that he/she does not conjory any other stipend/scholarship from any other sources for the course he/she is currently undergoing.

(4) Selected students should execute an undertaking not to switch over to any other subject/course till he'she finished the course for which the scholarship is awarded

4. DISQUALIFICATION FOR PAYMENT OF SCHOLARSHIP :--

Any break in the course for any reason will disqualify the student and will result in the forthwith withdrawal of the award of the Scholarship.

5. MISCELLANEOUS PROVISIONS :---

Mere passing of an examination (University Provision) of the course does not ensure continuation of the award for the next course. Fresh application should be submitted before the start of a new Academic Session accompanied by relevant documents for fresh evaluation.

(2) The Department does not bind itself to employ the Awardee when he/ she finished the course for which the Scholarship is awarded.

6. REPEAL AND SAVINGS :---

(1) With the commencen ent of these rules, the rules made and enforced under this Department No. J. 14014/Science/10/88-CST dated 6th October, 1988 shall stand repealed.

(2) Notwithstanding such repeal, any action taken under the rules so repealed shall be taken into account asaction taken under these rules.

#### RULES FOR ALLOCATION OF SEATS AND GRANT OF STIPEND, ETC. UNDER THE SERICULTURE DEPARTMENT

The Governor of Mizoram is pleased to make the following Rules for allotment of seats, selection of student/trainees and granting of stipend etc, to the students intending to take up technical studies in Sericulture in any recognised Institution of India as follows, namely :-

- Difinitions. 2 In these rules, unless the context otherwise requires,-
  - (a) "bond" means and agreement bond to be executed by a student in accordance with the provision of rule 8 of these rules;
  - (b) "Bonafide resident" means a person who is a permanent resident of Mizoram;
  - (c) "Certificate Course" means a Certificate Course Training in Sericulture;
  - (d) "Degree Course" means degree course in Sericulture:
  - (e) "Department" means the Seliculture Department;
  - (f) "Diplor a Course" means Diploma Course in Sericulture;
  - (g) "Director" means Director of Sericulture;
  - (h) 'Government' means the state Government of Mizoram:
  - (i) 'Governor' means the Governor of Mizoram;

- (j) "Post Giaduate Diploma" means post Graduate Diploma Course in Sericulture;
- (k) "Scheduled Caste/Scheduled Tribe" means the Scheduled Caste/Scheduled tribes as shown in the third Schedule to the State of Mizoram Act, 1986.
- (1) "Short Term Course means training in all kinds of technologies in Sericulture for non-matriculate conducted at the Sericulture Training Centre, Zemabawk or other places by the Government and in any Institution outside Mizoram where such training are imparted and the duration of the training course is one month or above or as prescribed by the Competent Authorities;

Application for admission and stipend 3. Application for admission to the Institution of studies shall be invited by the Director, Sericulture from the intending students by advertisement giving reasonable time prior to the commencement of academic sessions as may be deemed suitable and proper in prescribed Form in Appendix A with other necessary particulars.

> (a) A Candidate should be a bonofide resident in Mizoram. end. b) A candidate should be a member of Scheduled Caste or Schedule Tribe.

- (c) Eligilibility for seats and stipends for prosecution of studies in Sericulture Training Courses shall depend on fulfilment of the terms and conditions as may be prescribed by the Governor from time to time for various branches of Technical Studies.
- (d) A stipend holder under these Rules shall not hold any other Scholarship/stipend. If awarded a merit Scholarship/stipend, the student may exercise his/her option for either of these two scholarship/stipend whichever is beneficial to him/her and shall inform the Government through the Head of Institution the option so made. No stipend shall be paid to the student under these rules from the date he/she accepts another scholarship/stipend.
- (e) Payment of stipend will depend of the satisfactory attendance/progress and conduct of the student. If it is reported by the Head of Institution at any time that student has by reasons of his/her own act or default, failed to make satisfactory progress or has been quilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without permission of the authorities concerned etc., the Government may stop or withhold further payment of the stipend for on such period as it may think fit.

(f) If a candidate is found to have obtained a stipend by false statements, his/her stipend will be cancelled forthwith and the amount paid will be recovered at the discretion of the Governor. 

- (g) A stipend may be stopped if the stipend holder changes the subjects of the course of study for which the stipend was originally granted or changed with prior approval of the Governor. The Head of Institution shall report such cases to the Government and stop payment of the stipend amount. The amount paid may also be recovered at the discretion of the Governor.

(a) On expiry of the last date of submission of application by the student for allocation of seats and for stipend the Director, shall prepare a statement of all applications with delailed particulars in terms of advertisement and shall forward the, statement as prepared along with such applications to the Secretary to the Department concerned within the time limit as may be fixed by the Department.
  - (b) On receipt of applications from the Director as stated in clause (a) above, the Secretary to the Government who is the Chairman of the Selection Board shall convene the meeting with the following members of the Selection Board for scrutiny and final allocation of seats :-

  - (ii) Secretary to the Government of Mizoram, Personnel and Administrative Reforms Department or his representative Member.

#### Duration of 7. (a) The grant of stipend once made will tenable for the stage at which it is given to the completion of the course subject to good conduct and regularity in attendance.

- (b) Stipend may be renewed from year to year.
- (c) If a student studying Post Graduate. Diploma Course, Degree Course, Certificate Course or Short Terms Course fails in the examination for the first time in the entire course of the study, he may be given another chance by renewing the stipend provided the student is required to attend the class as a regular student and the Governor is satisfied that the reason for such failure is not due to negligence and carelessness on the part of the stipent, and that would be treated as a renewal case.

For a student staying in Post Graduate Diploma Course, Degree Course, Certificate Course or Short Term Course, the stipend may be renewed up to the extent of only too failures which should not be consecutive during the entire course of study provided he is required to attend the class as a regular student and the Governor is satisfied that the reasons for the failure is not due to negligence and carelessness on the part of the student.

- (d) The selected candidates may be given Travelling Allowances entitled to initial joining the Institutton and also for return journey on completion of the whole course as well as the Travelling expenses on study Tour conducted by the Institution.
- 8. Student selected for stipend shall execute a Bond in prescribed Form appended hereto as Appendix 'B' which states that on successful completion of the course for which the stipend is awarded one shall serve under the Government for a minimum period of five years, in case the student leaves the College/Institute before passing the final course without the permission of the Government for any reason whatsoever including illness, discharge or dismisal for misconduct or after having entered in the Government service if he/she refuses to serve the period specified in the bond shall be liable to refund all sums paid to him/her by the Government while in studies with 5% interest theron.

- 9. (a) The stipend to the student shall be payable from the month of his/her joining the course of study to the month in which the final examination is completed.
  - (b) The stipend shall be payable to student studying courses including summer/winter vocations falling in their course of study.

Execution of Bond

- (c) The amount of stipend due in respect of the student shall be paid through the Head of of the Institution.
- (d) In addition to the stipend, the Student shall be paid the expenditure for study tours organised by Institutions at the rate of actual fare for road and rail journeys, provided the expenditure is certified by respective Institution authorities.
- (e) In the case of the death of a student the amount of stipend due to him/her up to the end of the month the student has attended the Institution shall be paid to the parents/legal quardian by the department after obtaining the death certificate of the student mentioning the last date of his her attending the class from the Institution where he/she studies.
- (f) The statutory fees and tuition fees for each course as prescribed by the Institution for each trainee will be borne by the Department.
