NOTIFICATION

No. B.-11014/6/88-TOUR the 21st September, 1989. The Governor of Mizoram is pleased to fix the fare of Super Deluxe Bus under Tourism Department for Tourist purposes at the rates given below :—

- (a) Rs. 600/- per day for any local journey covering a maximum distance of 80 km from garage to garage between 6.00 a.m. and 9.00 p.m. Rs. 8/- for every km beyond 80 km will be charged extra in case the maximum distance limit is exceeded.
- (b) Rs. 8/- per km for one way journey from garage with halting charge of Rs. 35/- per hour or part thereof. Rs. 6/- per km for the return journey.
- (c) Rs. 400/- per day for halting charge overnight. If and when the Bus is required to halt over-night at any place outside the headquarters after a journey of less than 100 km, it will be construct to have halted over-night for one day. For halting after a journey beyond 100 km, no halting over-night will be charged till 6 a.m. next day. Any halt beyond 6 a.m. next day will be charged at the rate of Rs. 35/- per hour or part thereof.

- (d) For package tour conducted by the Department from Aizawl to Tamdil Lake, Rs. 125/- per ticket will be charged inclusive of breakfast, lunch & tiffin. For such conducted tour, the Bus will leave Aizawl in the morning and return to Aizawl same day after the tour as per programme is over.

CONDITIONS ;..

1. It shall be the responsibility of the hiring party to make good any loss or damage caused to the Bus due to their fault. In this regard, the decision of the Joint Director, Tourism Department shall be final.

2. Local private bodies like recognised Association/Churches may also utilise the services of the Bus provided they ensure that the Bus will be utilised by them for the return journey on payment of hiring charge/parking charge as fixed by the Government.

BOUNDARY DESCRIPTION OF RATU TOWN

AREA : 608. 72 Hectares

: 6.09 sqkm.

STARTING POINT :

B.P. No. 1 is fixed on the narrow saddle called Dilkawn which is the starting point of Dillui. The Pillar is fixed at the western side of the BRTF road which is 24deg 5' 18" lat and 93deg 55' 46" long.

BOUNDARY :

EASTERN SIDE :

The boundary line follows down the stream called "Uilui ram lam" it then runs 50m(H) below the BRTF road crossing Uimual, Bungbul lui and meet the RSK road at the Silailawn mual. The line then follows the RSK road. B.P. No. 2 at 24deg 5' 58" lat and 93 deg 55' 27" long on the bank of Awnlui Tuikhur lui. The line then follows RSK roads crossing stream called Tlak lui, Zawngsih lui up to Rahnam hnar kawn where B.P. 3 is fixed. The place is 24deg 6' 20" lat and 93deg 56' 17" long. The line then straightly directs to Fahtlang then crossing Darnam lui, B.P. No. 4 is fixed at 24deg 6' 53" lat and 93deg 55' 41" long which is locally named Permana huan mawng kawn. and Luangmual dam lui. B.P. No 5 is fixed at "Bandar mual" namely Lalthuneia lo lu kawn which is 24deg 7' 33" lat and 93deg 55' 47" long. The line then run north east crossing a stream named "Mel 59 lui" B.P.No. 6 is fixed at 24deg 7' 48" lat and 93deg 56' 01" long locally known as Bukpui mualte lu kawn. The line runs just 50m(H) below the BRTF road crossing Bukpui Mualte lui etc. B.P.No 7 is then fixed at 24deg 8' 14" lat and 93deg 56' 01" long.

NORTHERN SIDE :

The boundary line bends west running 50m(H) below the main road upto Bapui ramlam lui hnar kawn where B.P.No 8 is fixed at 24deg 8' 16" lat and 93deg 55' 30" long.

WESTERN SIDE :

The line runs from B.P.No. 8, 50m(H) west of Old Vervek road, then BRTF road upto the tributary of Melkawn lui. B.P. No 9 is fixed at 24deg 7' 25" lat and 93deg 55' 17" long. The line then runs 50m(H) west of the BRTF road upto the PHE Test path. B.P. No. 10 is fixed at 24 deg 7' 9" lat and 93deg 55' 18" long which is north west of Forest IB. The line then follows the PHE Test path upto Khankawn which is 24deg 6' 17" lat and 93deg 54' 45" long. The line follows Down the stream Tuizal the confluenc of Saihum lui where pillar No. 12 is fixed at 24 deg 6' 25" lat and 93deg 54' 45" long. The line from here follows Saihum lui and then Darruma huan luite upto EGS road. Here B.P.No 13 is fixed at 24deg 6' 8" lat and 92deg 55' 5" long. The line follows EGS road upto Changa kai lui B.P. No. 14 is fixed at 24deg 5' 44" lat and 93deg 54' 59" long on the bank of the stream.

SOUTHERN SIDE :

The line runs at the upper edge of the cliff of Khawpui hmun mual and meet Dillui 500m(H) west of Dilkawn where pillar No. 15 is fixed at 24deg5' 17 lat and 93deg55'15" long. The line finally follows Dillui up and meet the starting point closing the boundary line here.

2ND GRADE :

Both sides of the main road/street within the perpendicular distance of 100 ft or 30.48m (horizontally) from the side of the road/street subjected those sites which are having frontage/return-frontage to the side of the road/street only of all the Truckable or Jeepable road which are not included in the 1st grade within the specified town area.

3RD GRADE :

All land which are not included in the first and second grades within the specified town area.

NOTES :

1. All Government residential area for V.I.P's only of Government of Mizoram are put under the 1st grade.
2. If there is overlap between the grades the higher grade has to supersede the lower one.

3. Land which is included under any of the grade but has no frontage/return-frontage to the side of the road will be classed as the next power grade.
