### RULES AND PROCEDURES FOR ENLISTMENT OF CONTRACTORS UNDER PUBLIC WORKS DEPARTMENT, MIZORAM.

No.PWM-295/84/Pt/4 the 30th November, 1989. In partial modification of this Department's Notification No. PWM-276/82/72 dated 23.9.85, the Governor of Mizoram is pleased to amend the Paras under Rule 3,5 and 6 of the Rules and Procedures for enlistment of Contractors under Public Works Department, as given under, with immediate effect.

#### 3. CLASSES OF CONTRACTORS :

- ii) Class - II : Qualified to tender for works upto Rs. 12.00 lakhs.
- iii) Class - III : Qualified to tender for works upto Rs. 4.00 lakhs.
- iv) Class - IV : Qualified to tender for works upto Rs. 1.50 lakhs.

#### 5. AREA OF OPERATION OF CONTRACTORS :

- ii) The area of operation of Class II Contractors will be the whole of Mizoram.
- iii) The area of operation of Class III Contractors will be one P.W.D. Circle.
- iv) The area of operation of Class IV Contractors will be one P.W.D. Division.

#### 6. QUALIFICATIONS :

- 1) Class - I :
  - a) Contractors desiring registration as Class I Contractor should have satisfactorily executed at least 3 works of not less than Rs. 500,000/- each, at least one of which shall be of building work, and the aggregate value of all works executed should not be less than Rs. 20.00 lakhs.

2) CLASS - II :

- a) Contractors desiring registration as Class II contractors, should have satisfactorily executed at least one 3 works of not less than Rs. 100,000/- each, at least one of which shall be of building work, and the aggregate value of all works executed should not be less than Rs. 6.00 lakhs.
- b) The Contractors shall have at least 3 years experience as Class III Registered Contractors.

3) Class - III :

- a) Contractors desiring enlistment as Class III contractor should have satisfactorily executed works the aggregate value of which is not less than Rs. 3.00 lakhs.
- b) The Contractors shall have at least 3 years experience as a Class IV Registered Contractor.

AREA-4146000 Sqm.

STARTING POINT : Boundary Pillar (BP) 1st is fixed at a saddle named Phai-pungpeng' at the southern corner of Lungsen Town along Lunglei-Tlabung road which is 22deg 5' 05" lat and 92deg 35'55" long. This is used as starting point of the boundary.

**SOUTHERN SIDE :** Starting from B.P.No. 1, the boundary line run down westwards along a steam upto Chhimro lui B.P.No. 2 is fixed This is 22deg 51' 57" lat and 92deg 35' 41" long. The line follows up Chhimro lui to the saddle and follows down the stream 'Ihianga vai lui'. B.P. No. 3 is fixed at the conjunction with a stream from Police Quarter. This place is 22deg 51' 39" lat and 92deg 35' 17" long. The line follow the stream which start from Police quarter upto 500m (H). B.P. No. 4 is fixed at 22deg 51' 47" lat and 92deg 35' 30" long. The line runs up to the conjunction of Gate Kawn stream and Dumdut stream. Here B.P. No. 5 is fixed at 22deg 52' 11" lat and 92deg 35' 07" long. The line then follows up Dumdut Stream and B.P. No. 6 is fixed at the conjunction with Khawhnuaikawn which is 22deg 52' 25" lat and 92deg 35' 06" long. The line turns to south west up to the last saddle of Arsariahtlang B.P. No. 7 is fixed there at 22deg 52' 17" lat and 92deg 34' 51" long. The line then turns west meeting Sakei thihna lui where B.P. No. 8 is fixed. This place is 22deg 52' 18" lat and 92deg 34' 43" long.

**WESTERN SIDE :** The boundary line follows up the stream Sakeithihna lui upto the main road. B.P. No. 9 is fixed at pumpelhkawn which is 22deg 52' 40" lat and 92deg 34' 37" long. The line then follows down a steam northern side upto Lamhla lui where B.P. No. 10 is fixed. This place is 22deg 52' 49" lat and 92deg 34' 38" long.

**NORTHERN SIDE :** The boundary line turns to north east following Lamhla lui and B.P. No. 11 is fixed at Lawngpuikawn. This is 22deg 52' 56" lat and 29deg 39' 57" long. The line runs in the same direction upto Pengthuum where B.P. No. 12 is fixed. This is 22deg 53' 11" lat and 92deg 35" long.

#### **EASTERN SIDE :**

The boundary line turns to south east following an old road upto the spur where B. P. No. 13 is fixed. This is 22 deg 53' 03" lat and 92deg 35' 41" long. The line still follow the road upto B. P.
