CORRECTION SLIP NO 64.

1. A second proviso to Rule 10 of Part II of Chapter IX at page 76 of the High Court Rules be added as follows:—

“Provided further that the Chief Justice may, by a general order, direct that in any or all classes of appeals from original orders and decrees, paper books shall be either typed or cyclostyled and need not be printed and that such order shall take effect from the date of its publication in the Official Gazette and shall remain in force till such time as may be directed in the order”

EXECUTIVE ORDER NO. 14/72.

Memo. No. PC/REV/11/72/15 the 14th July, '72. In exercise of the powers conferred by sub para (I) of para 8 of the Sixth Schedule to the constitution and in pursuance of the provision of section 9 of the Pawi—Lakher Autonomous Region (Land and Revenue) Act, 1960, the Executive Committee of the Pawi District Council is pleased to prescribe the land value and the rate of Land Revenue thereof payable by persons holding such lands under Certificate of Land Settlement.

<u>Class.</u>	<u>Land value.</u>	<u>Tax payable per annum.</u>	<u>Minimum ceiling</u>
I. Shops at Lawngtlai/ New Chawngte	Rs. 10/-per sqm.	2½ % of L.V.	35.00

III. -do- in other places & residential at Lawngtlai/New Chawngte Bualpui/Diltlang/ Sangau	Rs. 5/- "	½ % "	25.00

While making assesment, any fraction less than 50 paise shall be ignored but if the fraction is more than 50 paise, it shall rounded up to a rupee.
