(ORDERS BY THE GOVERNOR) NOTIFICATIONS

No. LAD/VCA-98/88/47 (A), the 10th February, 1993. Serious allegations against Kanghmun V/C was received by the Govt. To find out the truth, thorough inquiry was made. From the inquiry reports, Explanation by the V/C President and proper appreciation of the circumstances, the following are found—

- 1. The village Council incurred expenditure without consulting the VDC and therefore without the knowledge of VDC.
- 2. Expenditure of Rs. 5,924/- out of the grant was for the purpose other than for which the money was sanctioned.
- 3. The deduction by BDO, Reiek of Rs. 4,000/- out of the sanction amount for payment of expenses to various persons was with the consent of V/C President.
- 4. An amount totalling Rs. 12,100/- was given as loan to twenty different persons. This is very irregular.
- 5. Account Book has not been maintained properly.

Besides the above, an amount of Rs. 27,332/- received from BDO Reick for expenditure on labour. But the names of the labours were not shown as payment not recorded at all.

It is also seen that on proper estimation after on the spot visit by DLAO, VDC Chairman and others the work done by the V/C for which Rs. 40,000/-was spent was not reasonable and that the amount actually spent could not have been more than Rs. 22,000/-. On this ground alone it can safely be concluded that Rs. 18,000/- have been mis-utilised.

Considering all the facts stated above the V/C is too inefficient and is not honest in financial matter and therefore, it is not able to carry on the village Administration. Accordingly, the V/C is dissolved under section 25(1) of the Village Council Act, 1953.

- B. Tenure of the Committee:—Tenure of the Committee shall be 3 years from the date of constitution of the committee which should count from the date of issue of formal notification. The members of the Committee shall hold Office at the pleasure of the Executive Committee of the concerned District Council.

- I) Vice Chairman of the Committee shall be entitled to Salary, TA/DA and all other facilities as EMs of the District Council.
