## ANNEXURE-I.

## BOUNDARY DESCRIPTION OF MARPARA FOREST RANGE UNDER MAMIT FOREST DIVISION :

**NORTH :** Inter Village Boundary of Phuldungsei and Phulpui started from (BRTF) Marpara Road till it meets Mar River, following Mar River upstream and then it follows the boundary of Zopui and Parvatui village till it reaches Tut River.

**EAST :** The Boundary follows Tut River upstream till it meets inter-boundary of Aizawl and Lunglei, then it follows the said district boundary till it meets Mar River and follows Mar River downward till it flows towards south.

**SOUTH :** Mar River upto the point where it meets Tuipui River

**WEST :** It follows Tuipui River upward upto the meeting point of Tuipui River and Aivapui River, then it follows River Aivapui upto meeting point of inter-village boundary of Phuldungsei  
low the same inter-village boundary till it meets the starting Point.

## ANNEXURE-II.

## BOUNDARY DESCRIPTION OF KAWLKULH FOREST RANGE UNDER CHAMPHAI FOREST DIVISION.

**NORTH:** The Boundary starts from R. Tuivawl where Chhirdem stream meets the river. It follows Chhirdem stream till it meets R. Tuivai and follows up to the Point where R. Tuiphal meets R. Tuivai. Then the boundary follows R. Tuiphal upstream till it meets the point where Phalte stream meets.

**EAST :** It follows Phalte upstream upto its source, after crossing ridge it follows Düllai down stream till it meets R. Tuichang. It follows R. Tuichang downwards.

**SOUTH:** The boundary follows R. Tuichang and meets interdivision boundary of Aizawl- Champhai Division.

**WEST :** It follows village boundary of Vanchang-Lungpho then Chhawrtui-Rulam and meets the source of R. Tuivawl and then follows R. Tuivawl downwards till it meets the starting point.



## ANNEXURE - III.

## BOUNDARY DESCRIPTION OF RAWPUICHHIP FOREST RANGE UNDER MAMIT FOREST DIVISION.

- EAST :** Originating from the point where Saiphailui (major) meets Tlawng, the boundary follows the stream south-wards almost its extreme source and deflect eastwards crossing a ridge and meets another stream which originates near Tawitaw village and upto its meeting point with another stream coming from the south. Following that stream towards its source, it will catch the source of Daldawk after crossing Langpui-Hmunpui abandoned Jeep Road at a small saddle. It follows Daldawk up to the point where it meets Tanlui up to the point where another stream joins.
- SOUTH :** From there it follows another stream from its mouth and goes westwards upto its source. Then crossing a ridge it meets Tuisen and follows its downstream till it meets River Tut in the west.
- WEST :** From the mouth of Tuisen at Tut it follows downstream northward upto the point where Tut and Tlawng meet each other.
- EAST :** From the point where Tut meets Tlawng the boundary follows Tlawng River after passing the mouth of Saiphallui (minor) it meets the mouth of Saiphallui (major) at Tut (starting point)

The boundary follows the natural land marks as far as possible.

## ANNEXURE -IV

## BOUNDARY DESCRIPTION OF BILKHAWTHLIR FOREST RANGE UNDER KOLASIB FOREST DIVISION.

**Starting Point :** From 80 Km post Silchar-Kolasib NH-54.

- NORTH :** From the starting point it runs to the east direction following one nearest brook till it meets Saiphallui. From the meeting Point with Saiphallui it runs southwards to west source of the same river upto the 1st rivulet following the Saiphallui from the eastern side. From the source of this small rivulet it crosses hill range and meet source of river meeting with Dochhumalui. It again runs from the Dochhumalui it runs eastwards along the source and then turns southwards reaching below the second high hillock of Dochhuma's area saddle in the north side. From here it runs along the saddle meeting Buarchep saddle and meets Cheptelui in the north of Chawnpui village in the north-east boundary with Saipum Forest Range.



**EAST :** From the meeting point of its northern boundary with R. Serlui the boundary runs southwards along R. Serlui. Then it runs along R. Serlui towards its source southwards till it meets innerline Forest Reserved boundary in its south-east corner.

**SOUTH :** From the meeting point between R. Serlui and innerline Reserved Forests, the boundary runs along the innerline Reserved Forest till it meets R. Chemlui. From R. Chemlui it follows R. Chemlui upto confluence with R. Kemlui. Then it follows R. Kemlui till it meets N.H. 54 at Khuangdai kawn. From there it follows inter Range boundary with Kolasib Range till it meets source of Sihlui in the south-west corner.

**WEST :** From the source of Sihlui it runs along the source of R. Sihlui crossing a hill range. From the hill it goes down the source of Hmarluangpui till it meets Chhimluangte. Then Satalui to Chhimluanglui. From Chhimluanglui it runs towards its source till it meets a rivulet in the eastern side of Chhimluang against Pu, Thansanga's pond. From Pu, Thansanga's pond it connects 60 Km Silchar to Kolasib N.H.54, its starting point in the north-west corner.

#### ANNEXURE — V

#### BOUNDARY DESCRIPTION OF SIALSUK RANGE UNDER THENZAWL FOREST DIVISION

**NORTH :** The boundary starts at the confluence of River Tlawng and Changte in the North and follows the latter upstream to its source at the base of Hmuifang Tlang at the inter-village boundary of Hmuifang and Chamring. It then follows the inter-village boundary of Lamchhip and Chawilung as far as it reaches till it reaches the river Mat.

**EAST :** The boundary then follows River Mat downstream till it reaches the Bailey bridge on R. Mat at Serchhip-Thenzawl Road.

**SOUTH :** From the bridge on river Mat, it follows the inter village boundary line of Sailam and Thenzawl till it reaches River Lau in the west. Thence it follows River Lau downstream till the said river meets River Tlawng.

**WEST :** The boundary then follows River Tlawng downstream till it meets river Changte in the north at the starting point.



## ANNEXURE-VI

BOUNDARY DESCRIPTION OF BUNGTLANG FOREST RANGE UNDER  
THENZAWL FORESTS DIVISION

- NORTH :** The boundary line starts at the confluence of River Mat and Matvate Lui thence it runs along Matvate Lui upstream and it crosses Aizawl-Lunglei main Road at the point of Inter-village boundary line of Keitum and Bungtlang, thence it runs in the eastward direction upto River Tuichang.
- EAST :** The eastern boundary line River Tuichang downstream in a southerly direction upto the meeting point of inter-division boundary line of Lunglei Forest Division and Thenzawl Forest Division where Mauva Lui meets R. Tuichang.
- SOUTH :** The Southern boundary line follows the inter-Division boundary of Lunglei and Thenzawl Division along the Thiltlang and Pangzawl in the westernly direction at the point where Thilva Lui meets River Mat.
- WEST :** The Western boundary line follows R. Mat upstream to meet the starting point of Northern boundary line.

## ANNEXURE-VII

BOUNDARY DESCRIPTION OF MUALTHUAM FOREST RANGE,  
THENZAWL FORESTS DIVISION

- NORTH :** Northern boundary starts from R. Tlawng at the meeting point of inter-village boundary of Neihloh and Kangmun villages. Thence it follows villages and it crosses Thingva Lui, thence it goes along inter-village boundary line of Kangmun and Buangpui villages upto R. Vanva.
- EAST :** The eastern boundary line runs along R. Vanva upto the meeting point of inter-village boundary line and the confluence R. Vanva. Thence it follows Nurai Lui upstream to meet the source of Burbun Lui and Vanva Lui. Thence it goes along Vanvate Lui south eastern direction upto the confluence of Vanvate Lui and R. Mat. Thence it follows R. Mat southerly direction upto the confluence of R. Vanva and R. Mat.
- SOUTH :** The southern boundary line follows the inter-Division boundary line of Thenzawl Forest Division and Lunglei Forest Division upto River Tlawng.
- WEST :** Thence it follows River Tlawng downstream to meet the starting point of Northern boundary line.



## ANNEXURE—VIII

BOUNDARY DESCRIPTION OF WILDLIFE SANCTUARY RANGE  
HEADQUARTER AT RAWPUI UNDER THENZAWL FOREST DIVISION

- NORTH :** The Northern boundary line starts at the confluence of River Mat and Matvate Lui thence it runs along Matvate Lui upstream and it crosses Aizawl-Lunglei main road at the point of inter-village boundary line of Keitum and thence it runs in the eastward direction upto River Tuichang.
- EAST :** The eastern boundary line follows River Tuichang downstream in a southerly direction upto the meeting points of inter-Division boundary line of Lunglei Forest Division and Thenzawl Forest Division where Mauva Lui meets River Tuichang.
- SOUTH :** The Southern boundary line follows the inter-Division boundary of Lunglei and Thenzawl along the inter-village boundary of Thiltlang and Pangzawl in the westernly direction at a point where Thilva Lui meets River Mat.
- WEST :** The western boundary line follows River Mat upstream to meet the starting point of Northern boundary line.

## ANNEXURE—IX

## BOUNDARY DESCRIPTION OF PHULDUNGSEI WILDLIFE RANGE

- NORTH :** The Boundary starts from Saithah village crossing the saddle and runs directly westwards till it meets the meeting point of Seling Lui and Khawthlang Tuipui.
- WEST :** Western boundary starts from the meeting point of Seling Lui and Khawthlang Tuipui. It then follows Khawthlang Tuipui downstream till it meets Aivapui Lui.
- SOUTH :** The Southern boundary starts from the point where Khawthlang Tuipui and Aivapui Lui meets. It then follows Aivapui Lui upstream upto its source till it meets Thingthupui Lui. The boundary thence follows Thingthupui Lui upstream till it meets BRTF Road.
- EAST :** The eastern boundary starts from the point where Thingthupui Lui and BRTF Road meets. It then follows the BRTF Road till it meets Saithah village point.



## ANNEXURE - X

BOUNDARY DESCRIPTION OF CHHINGCHHIP FOREST RANGE UNDER  
THENZAWL FOREST DIVISION

**NORTH :** The boundary starts from the point where the inter-village boundary of Phulmawi and Tlungvel meets R. Tuirial. It then follows the said inter-village boundary eastwards crossing Aizawl to Lunglei road upto R. Tuirini. Then it follows R. Tuirini upstream towards the south upto the confluence of Khuailui. The boundary then follows Khuailui in the south-easterly direction upto the point where the inter-village boundary of Hualtu and Tawizo meets Khuailui. From that point, it follows the said inter-village boundary towards south-easterly direction and proceeds further following the inter-village boundary of Hmuntha and Maite Tuivawl.

**EAST :** Thence, the boundary follows R. Tuivawl upstream upto the source. Then it goes towards south and follows inter-village boundary of Khawbel and Rullam. The boundary then goes further towards south and covers the village boundary of Thentlang.

**SOUTH :** The boundary then follows inter-village boundary of Thentlang and Sialhau upto R. Tuikum. At the follows R. Tuikum upstream till it meets the inter-village boundary of Chhingchhip and Chhiabtlang. Following the said inter-village boundary, it goes westwards crossing Aizawl Lunglei road till it meets R. Mat. The boundary then goes towards west following the inter-village boundary of Chawilung and Lamchhi, and goes further westwards till it meets the source of R. Tuirial.

**WEST :** Thence, the boundary follows R. Tuirial downstream towards north till it meets the starting point.

## ANNEXURE-XI

BOUNDARY DESCRIPTION OF THE FARKAWN FOREST RANGE UNDER  
CHAMPHAI FOREST DIVISION

**NORTH:** The boundary starts at the place where Tlawva Lui and Ramri Lui between Thekpui and Khankawn village meets. From the meeting point, it runs towards north and east following Tlawva Lui upstream till it reaches the meeting point of Tlawva Lui and Zalhva Lui. From there it follows Zalhva Lui upstream towards north-east till it reaches shaddle from where it runs towards north-east following Ramri Lui downstream and follows Iva Lui downstream till it meets R. Tiau.

**EAST :** Following R. Tiau downstream towards south all along the inter-national boundary of India and Burma.



**SOUTH:** It follows R. Tiau down stream towards west and north-west till it reaches the place where Tlawva Lui meets R. Tiau,

**WEST :** From the meeting point the boundary runs towards the North following Tlawva Lui upstream and reaches the starting point.

### ANNEXURE—XII

#### BOUNDARY DESCRIPTION OF THENHLUM FOREST RANGE UNDER THENZAWL FOREST DIVISION

**STAR-  
TING  
POINT:** The boundary starts from the confluence of River Mar and Sekam Lui (inter-district boundary of Aizawl and Lunglei).

**NORTH:** The boundary follows Sekam Lui upto the source and then goes eastward along the inter-district boundary of Aizawl and Lunglei till it meets the source of Zawlpui Lui downstream till it meets R. Tut.

**EAST :** Thence, the boundary follows R. Tut upstream towards South upto a point where it is joined by small stream which has its source near Changpui Village. It then moves south-wards crossing Changpui village and meets Changpui-Khawltlang road upto a point at the inter-village boundary of Lungchem and Khawltlang.

**SOUTH-** The boundary then follows the said inter-village boundary in the westernly direction crossing Tuisen Lui and R. Kau. It then follows the village boundary of Bnghmun South and Belkhai and then follows the same upto Bnghmun-Belkhai Road.

**WEST :** Thence, the boundary line follows Bnghmun-Thenhlum road in northernly direction to meet Lungphun Lui after the confluence of Kau Lui and Belklang Lui thence it follows Lungphun Lui upto the confluence of R. Mar. Thence goes along R. Mar upstream to meet the starting point of Northern boundary line which is the confluence of R. Mar and Sekam Lui.
