#### BOUNDARY DESCRIPTION OF TLABUNG TOWN LUNGLEI : DISTRICT.

AREA : 11943000 Sqm (Approx)  
1194.30 Hect „  
11.94 Sq.km „

**STARTING POINT :** Boundary Pillar (B.P.) No. 1 is fixed at a point where the BRTF road (Lunglei to Tlabung) crosses Sakuh lui at the North Eastern corner of Tlabung town area. From here the measurement of Tlabung Town boundary starts.

- EAST SIDE** : From the starting point the boundary line follows up Sakuh lui crossing Barapansury road upto B.P. No. 2 fixed at Bungbukawn near Lungno Hillock. It then runs down at brook till it meets Lungno lui, following a long Lungno lui down upto a precipice. B.P.No. 3 is fixed at the edge of the precipice.
- SOUTH SIDE** : The line then runs western direction along the edge of the cliff till it meets Thlanmual lui where B. P. No. 4 is fixed. Then the line follows down Thlanmual lui upto B. P. No. 5 fixed at the confluence of Tuipui river and Thlanmual lui. The line then follows down the river Tuipui upto B.P.No. 6 fixed at the confluence of Tuipui River and sovasalosora stream.
- WESTERN SIDE** : From the B.P.No. 6 the line follows up the stream Sovasalosora upto the end of the stream upto Mualkim tlang and then following the ridge of the spur, it crosses a sadie (Kawnzam) and it then follows Khuangchawi tlang upto B.P.No. 7 fixed at the saddle on the path way side of Lam-thai. From here, the line follows EGS road (old road approach to Puankhai road) upto B. P. No. 8 fixed at the junction with Puankhai road.
- NORTH SIDE** : The line follows down a tributary of Vangchhopa Lui. After meeting Vangchhepa lui it follows down Vangchhepa lui upto the confluence with Tuipui river where B. P. No. 9 is fixed. The line from B. P. No. 9 follows down Tuipui river down upto Phivawk lui conjunction, where B.P. No. 10 is fixed. Then it follows up Phivawk lui upto B. P. No. 11 fixed at Camp Group kawn. The line then follows down Khualzin lui upto the confluence with Sakuh lui where B.P.No. 12 is fixed. From the confluence, it follows up Sakuh lui upto B.P.No. 1 closing the boundary line of Tlabung Town.

Hence the town area alters increasing the area at West side of Tuipui (Karnaphuli) including Nunsuri, Serhuan and Dinthar.
