In exercise of the power conferred by Sub-Section (i) of section 432 of the Code of Criminal Procedure 1973 (Act No. 11 of 1973) and Rule 17 of the Assam Jail Manual as applicable in Mizoram (Amendment) Rules 1986, the Governor of Mizoram is pleased to sanction State Remission on account of Republic Day 1994 in favour of prisoners who have been convicted by Civil Courts of Criminal Jurisdiction in the State of Mizoram as below :—

- (a) 30 days for sentence exceeding one year.
- (b) 15 days for sentence exceeding 6 months but less than one year.
- (c) 10 days for sentence exceeding 3 months but less than 6 months.
- (d) 5 days for sentence exceeding 1 month but less than 3 months.

Provided that convict has throughout maintained good conduct in Jail and has not committed any offence or been involved in any crime either inside the Jail or outside while on parole/furlough/bail etc.
