No. B. 28011/1/91-AGR, the 31st January, 1994. The Governor of Mizoram is pleased to constitute the Local Management Committee for KVK Kolaisib with following members :—

Chairman : Secretary, Agriculture

Member Secretary : Director, Agriculture

- 1) Director, AH & Vety
- 2) Dy-Commissioner (Tech) Agriculture Rural Development
- 3) One big farmer to be nominated by D.C. Aizawl
- 4) One small farmer to be nominated by D.C. Lunglei
- 5) One farm woman to be nominated by M.H.I.P.
- 6) One progressive farmer to be nominated by Y.M.A.
- 7) Training Organiser, KVK Kolasib.

The membership of the local Management Committee of KVK shall be regulated according to the following rules :

- (a) If quorum is short by only one member, the Chairman shall be at a liberty to appoint any person as a substitute at that meeting of the LMC. Such substitute shall have all the right and privileges of the member committee for the meeting only.
- (b) Where a person becomes a member of the Committee by virtue of his office or the appointment he holds, his office or the appointment he holds, his membership of the committee shall terminate when he ceases to hold that office or appointment.
- (c) In case of death, resignation, insolvency, lunacy or conviction for a criminal offence, involving moral turpitude, the membership will terminate automatically.
- (d) When member himself declines to serve on the committee or his nominator refuses to grant him permission to serve on the Committee, his membership shall terminate.
- (e) When member does not attend three consecutive meetings of the Committee, the nominator should change the person keeping in view his continuous absence in three consecutive meetings of the Committee.
- (f) The nominated members of the Committee shall hold office for a period of three years from the date of his nomination.
- (g) If a casual vacancy arises during the three-years period such vacancy shall be filled in a like manner as the original vacancy and there person nominated/appointed to fill the vacancy shall serve on the Management Committee for the unexpired portion of the three years.

The L.M.C. shall meet on quarterly basis. The member-Secretary will convene the meeting with the consent of the Chairman. For convening the meeting 11 days advance notice should be given to the members with agenda notes for discussion. At least fifty percent of the members of the Committee should be present in the meeting for quorum. The committee shall perform the following functions :

1. Providing necessary guidance and leadership in building up the institution to fulfil its objectives.
2. Consideration of proposal for annual and Five Plans.
3. Periodical review of progress of the Training programmes fifty percent of time of the Committee should be devoted to this task.
4. Policy decision relating to the Krishi Vigyan Kendra and Trainers Training Centre.
5. Such powers as may be delegated by the ICAR/host institution.
