In continuation of this Deptt's Notification of even No. Dated 4. 2. 1992 providing incentive Cash Awards of Rs. 5000/- (five thousand) only to those successful candidates in the Civil Services (Preliminary) Examinations and Civil Services (Main) Examinations conducted by the Union Public Service Commission (UPSC), the Government has further decided that the incentive cash Award should be given once each to the

same candidate who qualifies/passes in the Civil Services Preliminary and Main Examinations. In other words, if a candidate passes the Civil Service (Preliminary Examination, more than once, he should be given cash award of Rs. 5000/- only once and another Rs. 5000/- should be given to the same candidate if he passes the Civil Service (Main) Examination.
