OFFICE MEMORANDUM

No. F. 21011/14/19-GAD, the 23rd February, 1994. As a part of austerity measure, it has been decided and conveyed vide O.M.No. FMC 42/89 dated 10. 2. 64 that official tours to places outside Mizoram are to be restrained. It is reterated that official tours outside the State may be undertaken only when it is obsolutely nessasary to undertake the same. The offices of Resident Commissioner and Liaison Officers of the Govt. of Mizoram should be fully utilised to persue matters pertaining to individua! Departments. When it is absolutely necessary to undertake official tours outside the State, approval of the Chief Secretary should be obtained in the following manner.

- (1) In case of Secretaries to the Government, once the written approval of the Chief Secretary is obtained, the relevant papers should be passed on to DP & AR. for issue of formal order sanctioning the tour. The order will inter alia, mention the purpose of the tour and the period thereof.
- (2) In the case of other officers staff working in the Secretariat formal order sanctoning the tour shall be issued by Secretariat Administration Department once written approval of the Chief Secretary is obtained. The approval will be solicited following the normal channel of controlling officers.
- (3) The Heads of Departments will route their proposals for tours outside the State through the Secretaries concerned. As and when such tours are approved formal order will be issued by the administrative departments concerned.
- (4) In the case of all other officers and staff, proposals for tours outside the State will be routed through the usual channel and the same will be put up to the Chief Secretary through the Secretaries concerned. Once the proposals are approved, formal order sanctioning the tour will be issued by the Head of Department/Head of office concerned.

It is further clarified that officers/Govt. servants will be treated as officials on duty in Mizoram Houses only when their tours are sanctioned through formal orders as mentioned above. All other cases will be treated as not on duty and will be charged tariff/room rent accordingly. Similar principle will be

followed in matters of release of prierity seats on Vayudoot/Indian Airlines under Government quota. T. A. Bills in respect of such tours should invariably be accompanied by a copy of the order sanctioning the tour failing which the bills should not be passed.
