Sealed a Cations are invited from reliable agencies of repute for undertaking the job of pheapgraphy and compilation of laminated photo identity cards with incorporated 16 ogram for electors of the State of Mizoram on a turn-key basis, and will be received upto 2:00 PM on 14.6.94 in the ed the same day immediately after 2 P.M. at the same place in the presence of representatives of the quotationers if any.

- 2. The size of the paper card should be 7cm vertical and 9cm forizontal without the transparent edges.
- 3. The size of the photograph of the electors to be incorporated on the identity card will be 3cm vertical and 2.5cm horizontal.
- 4. The hologram should contain the National Emblem (the three lions) which should be officed on the identity card itself in such a way that he hologram cannot be removed or peeled off without destroying the card. The hologram should be a circle with 2cm diameter affixed at the centre of the front page of the card.
- 5. The thickness of the paper for preparing the I.D. Card shall not be less than 165 grm, and the paper will be supplied by the Govt.
- 6. The laminating film should be of the minimum thickness of 125 microns and the lamination should be so fused that it cannot be opened without destroying the card. However, the duplicate copies need not be laminated incividually.
- 7. The photo identity cards are required to be made for electors of the 40(forty) numbers of Assembly Constituencies consisting of a total of 4, 5,021 electors in duplicate, original in laminated form and the duplicate without lamination. The job of photography will have to be undertaken at 784 polling stations located throughout the state. The entire turn-key job, will be settled with the successful quotationer within 7 days. The whole operation should be completed by the successful quotationer within 4 months from the date of issue of the work-order.
- 8. The work of photography at each polling station would have to be undertaken on date(s) to be fixed by the Electoral Registration Officer concerned and may have to be repeated on a second date(s) in cases of polling stations where more than 10% of the eligible electors remained unphotographed on the first date (s) of photography.

9.
