Whereas, in the entire Rural Devlopment Blocks of Khawzawl in Aizawl District and Lunglei in Lunglei District and Marpara 'S' Village, the Govt. of Mizoram have taken up a new Project known as New Land Use Policy, with a view to do away with the practice of shifting Jhum Cultivation by way of offering various alternative schemes to the jhumias (jhum Cultivators), it is considered necessary to stop the traditional way of keeping animals with the above R.D.
