In exercise of the powers conferred under Section 117 of the Motor Vehicles Act, 1988, and in supersession of all other Notifications issued in this regard, the Governor of Mizoram is pleased to prohibit parking of Heavy Vehicles on the following road stretches of Aizawl town:—

- (i) Kulikawn—Treasury Square—Bazar Bungkawn—Chandmary Chaltlang—Bawngkawn Road.
- (ii) Sikulpuikawn—Khatla—SBI Junction—Temple Point—Zodin Square Road.
- (iii) Raj Bhawan South Gate—CM's residenence Tuikhuahtlang and CM's residence—Sikulpuikawn via eastern road.
- (iv) Temple Point—Vaivakawn Road.
- (v) Bazar Bungkawn—Hausiama's Taxi Stand.

However, loading/unloading of goods or picking up or setting down of passengers by the above category of vehicles will be allowed.

The above orders shall come into force with effect from 1st May, 1995.

Heavy Goods Vehicles, Stage Carriages used as Bazar Buses and Tourist Vehicles used as Night Buses within the potified Urban arms of Dizawl town during the foll-lowing hours:—

i) Months of March to October

7.30 A.M. to 11.30 AM 2.30 Pm to 6.30 PM

ii) Months of November to February

8.00 AM to 11.30 AM 2.30 PM to 5.30 PM

However, Heavy Goods Vehicles used for transporting water, milk and petroleum products are exempted from the above restriction.

This restriction thall come into force with effect from 1st May, 1995.
