In pursuance of the recommendation of the Tenth Finance Commission the Governor of Mizoram is pleased to set up a Calamity Relief Fund for the State of Mizoram for meeting all relief expenditure on Natural Calamities. This fund will be in existence separate from the General Revenue of the State and contributions to this fund will be made by the Central and the State of Mizoram in the proportion laid down by the Tenth Finance Commission. The fund will be kept in the State Bank of India, Aizawl and will be administered by the State Level Committee.

2. Contribution to the fund by the Government of India and the State Govt. will be as follows :—

3. In respect of State Government's share of expenditure provision of fund will be made in the State Budget and the amount required from time to time shall be got sanctioned for deposit into the Bank account.

4. Following the creation of the fund, all expenditure arising out of Natural Calamities shall be met from out of this fund. The yearly addition to the fund as well as the accrual of interest thereon shall be used to meet the requirement.

5. The money put into the fund in a year and remaining unspent in that year or in the subsequent years would be available to the State at the end of the fifth year or thereafter for being used as a resource for the next plan.

6. Further, the Governor of Mizoram is pleased to constitute a State Level Committee headed by the Chief Secretary of the State Government of Mizoram to operate the fund.

The Committee shall consist of the following members :—

7. The State Level Committee shall decide on all matters connected with the financing of relief expenditure.

8. The State Level Committee will prescribe the norms for the amount that can be given or spent under each of the identified items given below :—

1. Gratuitous relief
2. Supplementary Nutrition
3. Assistance to small farmers/marginal farmers.
4. Employment Generation
5. Animal Husbandry
6. Assistance to Fishermen
7. Assistance to Artisans—Handicrafts sectors
8. Assistance for repair/restoration of damaged Houses
9. An emergency supply of drinking water (only for meeting requirements additional to on going plans schemes namely Viz : ARWSP)
10. Procurement, storage and movement of Fodder
11. Movement of useful Cattle for other areas
12. Provision of Medicines etc.
13. Additional Nutrient to animal feed.
14. Medical care

15. Evacuation of people affected/likely to be affected.
16. Provision for temporary accommodation, food, clothing, Medical care etc.
17. Air dropping of food and medicine.
18. A restoration to pre-calamity level of damaged public works.
19. Replacement of damaged medical equipments and lost medicines of Government Hospitals/Health Centres.
20. Operational cost of Ambulance services, Mobile medical teams, temporary dispensaries etc.
21. Costs of clearance of debris.
22. Costs of search and rescue measures.
23. Disposal of dead bodies, carcasses.
24. Post disaster Public Education.
25. Cost of Seed reserve.
26. Improvement to the flood Control amenities.

9. The member-Secretary of the State Level Committee shall maintain detailed account of the receipt and expenditure in respect of the fund in Central Treasury Rules form No. 4 and all vouchers shall be properly maintained for audit. At the end of each financial year, the Member-Secretary shall submit report to the Government indicating the details of transactions and the balance, if any, in the fund.
