# BOUNDARY, DESCRIPTION OF DARLAWN TOWN

STARTING POINT: At the entrance northern corner of Darlawn Town about 750m to eastern side from Lungphunlian, where stream called "Ramri Lui" meets

other stream, boundary pillar (BP) No 1 is fixed. This is 92deg 55'36" longitude and 24deg 3'9" Latitude. This point is used as the starting point of Darlawn Town Boundary.

EASTERN SIDE: From the starting point, the boundary runs to south east direction and Pillar No 2 is fixed at the confluence of of small streams to eastern side from Lungtatkawn at about I. 125 Km away which is 92deg 56'0.5" Longitude and '4deg2'49" Latitude. From B.P. No. 2 the boundary runs towards south till it meets the confluence of small streams. B.P.No.3 is fixed there that is 92deg 56'3" Longitude and 24deg 2'32" Latitude from B.P.No 3 the boundary runs towards south till it meets the confluence of stream when B.P.No 4 is fixed. This is 92deg 56'3" Longitude and 24deg2'10" Latitude. From B.P.No 5 the boundary runs to south east direction upto B.P.No.5 which is confluence of Khuailui and its tributary. B.P.No 5 is 92deg 56'22" Longitude and 24deg 1'40" Latitude. From this point the boundary turns to east up to the Saddle namely Belkhurkawn where B.P.No.6 is fixed. This point is 92deg 56'36" Longitude and 24deg 1'37" Latitude. From B.P.No 6 the boundary runs to south east direction upto the saddle called "Bialzau peng kawn" B.P.No 7 is fixed here and it is 92deg 56'55" Longitude and 24deg 1'11" Latitude. The boundary then turns to south west direction upto old Darlawn Village hill where B.P.No 8 is fixed. This is 92deg 56'27" Longitude and 24deg 0'35" Latitude. The boun lary runs to south west direction to meet the confluence of Tuikawr lui with its tributary B.P.No.9 is fixed here and is 92deg 5.'53" Longitude and 24deg0'24" Latitude. From here the boundary turns to south west direction following Tuikawrlui and B.P.No.10 is fixed at the confluence with a small stream at 92deg 56'15" Longitude and 24deg 0'10" Latitude. The boundary then turns to south west B.P.No. 11 is fixed at the confluence of Siktuithianglui with its tributary. This point is 92 deg 56'21" Longitude and 32 deg 59'40" Latitude, From B.P.No. 11 the line turns south east crossing the streem named Tuaia Vaului and Thaklui, B.P.No. 12 is fixed at the upper edge of Dampui ko which is 92deg 56'44" Longitude and 23deg 50'12" Latitude. The line then turns south crossing Tuilai lui B.P. No. 13 is fixed at Lalhlira Huan lui by the side of Aitlang road. This is 92deg 56'38" Longitude and 23deg 58'54" Latitude.

SOUTH SIDE: The boundary line turns south west B.P.No. 14 is fixed near Ngawzawl road along Thluaii Lui about 500m (H) from the BRTF Road. This is 92deg 56'8" Longitude and 23deg 58'26" Latitude. The line then follow up 1 hluaii Lui upto the main road. Chalchhuna's Memorial Stone Pillar is regarded as B.P.No. 15 which is at 92deg 88'55" Longitude and 23deg 58'25" Latitude. The line then turns to north enclosing Tlangnuam Running the edge of cliff. It then crosses Zotui B.P.No. 16 is fixed at spur 92deg 55'44" Longitude and 23deg 58'52" Latitude.

WEST SIDE: The line then turns north east along the edge of cliff i.e. west of the high hill of Sawleng Village. B.P.No. 17 is fixed at 92deg 56'3" Longitude and 23deg 59'14" Latitude. The line then turns north just west of the spur then meet Sedaikawn where B.P.No. 18 is fixed at 92deg 56'40" Latitude From Sedaikawn the boundary runs to north west direction and B.P.No. 19 is fixed at the confluence of Khawntlingi pa lui with small stream. This is 92deg 55'40" Longitude

and 23deg 59'56". The line again continues to the same direction upto B.P.No. 20 which is 92deg 55'0" Longitude line B.P.No. 21 is fixed there. This point is 24deg 0'34" Latitude. From here the boundary turns to west direction upto a hillock at 92deg 54'32" Longitude and 24deg 0'33" Latitude B.P.No.22 is fixed here.

From B.P.No. 22 the boundary turns towards north upto B.P.No. 23 which is 92deg 54'37" Longitude and 24deg 0'47" Latitude. The line turns from B.P.No. 23 to north east direction and B.P.N. 24 is fixed along a stream below Sedaikawn. This is 92deg 55'9" Longitude and 24deg 0'58" Latitude. From B.P.No. 24 the boundary runs to north west direction through Mauhak and B.P.No. 25 is fixed at a Stream. This, is 92deg 8 1'2" Latitude, the then follows the stream to north west direction. B.P.No. 26 is fixed at a hillock this point is 92deg 54'34" Longitude and 24deg 1'23" Latitude. From here the line continues the same direction upto Khanpui kawn where B.P.No. 27 is fixed. The point is 92deg 5'42" Longitude and 24deg 1'47" Latitude. From Khanpui kawn the boundary turns to the north west direction and B.P.No. 28 is fixed on the edge of Thenzawl. This point is 92deg 54'43" Longitude and 24deg 1'52" Latitude. The line continues the same direction up to the continues of Damlui below BRTF Camp B.P.No. 29 is fixed and is 92deg 55'13" Longitude and 24deg 1'59" Latitude. The boundary follow Damlui to north direction upto B.P.No. 30 which is 92deg 55'10" Longitude and 24deg 5'25"Latitude. The boundary runs from there to north west direction upto 92deg 5'50" Longitude, then, B.P.No. 32 which is 24deg 3'8" Latitude.

NORTH SIDE: The boundary then follow the stream called Lungphunlian lui upto Lungphunlian kawn where B.P.No. 33 is fixed. This is 92deg 55'll" Longitude and 24deg 3'10" Latitude and From Lungphunlian kawn the boundary across the BRTF main road where 11km stone to Ratu Village stands. The line then follows down a small stream up to the confluence here it meets to the starting point B.P.No. 1 as already mentioned in the first para.
