RANGE

Headquarter — Pangzawl
Area — 183 K.M. 2

GOEGRAPHICAL POSITION ; It lies between 92° 45' to 93° 0' East Longitude and 23° 0' to 23° 15' North Latitude.

BOUNDARY DETAILS

1. **NORTHERN SIDE** : The boundary line starts from the crossing point of 92° 45' East Longitude and 23° 15' North Latitude in the North Wester corner of the Range near Neihloh Village. It then turns towards south eastern-ly direction by following the Inter- district boundary line of Aizawl and Lunglei District till it meet river Tuichang.
2. **EASTERN SIDE** : It then follows river Tuichang towards southerly direction upto the Intervillage boundary of Pangzawl and Thiltlang Village.
3. **SOUTHERN SIDE** : The boundary line follows the inter-Village boundary line of Thiltlang and Pangzawl in westerly direction till it meets river Mat.
3. **WESTERN SIDE** : Lastly, the boundary line turns to northerly direction by following river Vanva till it meets the starting point.

ANNEXURE - II

BOUNDARY DESCRIPTION OF HNAHTHIAL SOIL & WATER CONSERVATION RANGE

Headquarter - Hnahthial
Area - 179 K.M 2.

GEOGRAPHICAL POSITION :- It lies between $92^{\circ} 52'$ to $93^{\circ} 0'$ East Longitude and $22^{\circ} 45'$ to $23^{\circ} 01'$ North Latitude.

BOUNDARY DETAILS

1. NORTHERN SIDE : The boundary line starts from the confluence of river Mat and the Vanva river in the north western corner of the Range. It then follows the inter village boundary line of Thiltlang and Pangzawl in easterly direction till it meets river Tuichang.
2. EASTERN SIDE : Then the boundary line follows river Tuichang towards southerly direction and then it meets river Chhimtuipui upto confluence of river Chhimtuipui and the Mat River.
3. SOUTHERN SIDE : It then follows the river Mat in westerly direction upto the confluence of river Mat and river Ngengruallui.
4. WESTERN SIDE : Lastly, the boundary line goes in northerly direction and it follows the Mat river till it meets the starting point.

Hnahthial Soil & Water Conservation Range includes the following village as mentioned below -

2. Denlung
3. Thiltlang
