Objective of the Council are as follows :—

(a) Organising donor recruitment, motivation and objection Programme to generate voluntary non-remunerated Blood donors, thereby eliminating the reliance on professional blood donors.

(b) Ensuring appropriate use of blood by avoiding whole blood transfusions, usage of substitute products using components from whole blood, apheresis, autotogus transfusion etc.

(c) Training of Technicians, Drugs Inspector, donor motivators and medical officers in relation to all operations of the blood centres.

(d) Development of State Level Nodal Centres and District Level Nodal Centres equipped for collection, storage components separation and distribution of blood and blood products.

(e) Linking of the nodal blood centres to District Hospitals Sub-District Hospital/First Reforsal Hospitals.

(f) Development of zonal training centres aimed at implementing the training programmes developed by National Council.

(g) Maintaining a database on the donor profile and database on the rare blood groups,

(h) Implementing the programme outlined by National Blood transfusion Council on the areas of organising voluntary Blood Donation Programmes, ensuring appropriate use of blood, providing infrastructure to Nodal centres etc.

(i) Implementation of national guidelines/standard developed by National Council for blood centre operation to be adopted by Nodal centres.

(j) Implementation of the policies developed by National Council or levying service charges for blood and its components.

(k) To finance research and study proposals aimed at furthering the objectives of State Council.

(l) To issue appeals and make application for money and funds for furtherance of the objects of the State Council and to accept for the aforesaid purpose, gift, donations and subscriptions of cash and securities.

(m) Receive donations, contribution, grants and financial assistance from individuals and organisations desiring to assist council for propagation to its activities and programmes.

(n) To purchase, construction, maintains and alter any building or works necessary or convenient for the purpose of State Council.

(o) To undertake and accept the management of any endowment or trust fund having objects similar to the objects of the State Council.

(p) To offer prizes and grant of scholarships including travelling scholarships/ fellowships in furtherance of the objectives of State Council.

(q) To create administrative, technical and ministerial and other posts under the society and to make appointments thereto on approval from governing body of the State Council.

(r) To establish a provident fund and/or pensions fund for the benefit of the State Council's employees and their family members.

Registered office of the State Council will be at Aizawl. The Society named "State Blood Transfusion Council" will be Registered under the Societies Registration Act, 1860.
