The general terms of reference of the Task Force shall be as follows :—

1. It will begin to operate with immediate effect till the 31st of August 1998 at the first instance.
2. It will assist, enable, advise and guide the consultant in the following areas of his responsibility.
 - 2.1. Framing of Education Policy and Education Act for Mizoram.
 - 2.2. Preparation of Rules for Mizoram Education service.

- 2.3. Improvement of quality of Education.
 - 2.4. Critical examination of educational administration in Mizoram—Structure and System, Delegation of Powers, Decentralisation, Streamlining of Inspection/Supervision of Educational Institutions, etc.
 - 2.5. Indepth study of Teacher Education with special reference to College of Teachers Education (CTE) and District Institutes of Education and Trianing (DIET)
 - 2.6. Review of existing Rules and Regulations of the Education Department.
 - 2.7. Development and Management of Higher Secondary Education.
 - 2.8. Improvement and Growth of Science and Technical Education.
 - 2.9. Establishment of Mizoram University.
 - 2.10. Any other matter relating to Education as may be assigned from time to time.
3. The main function of the Task Force shall be advisory and in that capacity it will be engaged in work, study survey and research, and then prepare findings and reports as a result.
 4. Members who are not Government servants, including retired personnel, will be entitled to nominal sitting allowances and reimbursement of reasonable actual expenses for transport to attend Task Force meetings.
 5. Other items and conditions shall be as may be determined by the Government from time to time.
