Bye-Laws No. 13

Affiliated member society shall have one vote by virtue of its ordinary membership. Proxies shall not be allowed. Besides, this one vote, the ordinary member shall have one additional vote also for every two lakh rupees transacted through the Federation during the previous financial year, maximum three votes for any member society. The voting right shall be determined along with Annual Accounts on the above basis and will be effective for the year till the next Annual General Meeting. The new Board will however exercise these voting rights only after the Annual General Meeting. Notwithstanding anything mentioned above, the nominated members of and existing member of Board of Directors shall each have equal rights to vote.

Bye-Laws No. 14**DISQUALIFICATION OF MEMBERSHIP OF MANAGING BODY :**

Member shall not be eligible for being chosen or being appointed as a member of the Managing Body of the Federation if such member—

- a) Is adjudged by a competent court to be insolvent or of unsound mind.
- b) has been punished with imprisonment for an offence involving moral turpitude.
- c) is concerned or participates in the profit of any contract with the society.
- d) wilful default from payment of any loan to the Federation.

Bye-Laws No. 16.1.1.**BOARD OF DIRECTORS**

The Board shall consist of the 17 (seventeen) members as follows :—

- 1) At least 9 (nine) members elected from the member societies.
- 2) Government nominees are as under :—
 - a) Registrar, Coop. Societies or his representative.
 - b) Director, A.H. & Vety. Dept. or his representative.

- c) One nominee of the N.C.D.C.
- d) One Piggery specialist nominated by the State Govt.
- e) Director, Food & Civil Supplies or his representative.
- f) Director, Agriculture or his representative.

- 3) Managing Director of the Federation (Ex-Officio).
- 4) One nominees of any other financing organisation if associated with the working of the Federation.

POWER AND FUNCTIONS OF CHAIRMAN

- a) He shall have overall control supervision on the administration, business and general affairs of the Federation. He shall preside over the meeting of General Body and Board of Directors.

- c) Approve and sanction expenditure on any of items as approved in the budget and such other expenditures as approved and sanctioned by the Board of Directors.
- d) Notwithstanding anything contained in the Bye-Laws empower the Managing Director to ascertain the opinion of the Board of Directors on any matter. He consider urgen. or expedite by circulation of papers to the members. Decision taken to be placed before the next Board of Directors meeting for confirmation.
- e) Sign the proceeding of all the meeting presided by him.
- f) Convene the meeting of Board of Directors and any other sub-Committee of which he is the President.
- g) Delegate any of his power and functions to the Managing Director.

- b) Competent to take decision as are of urgent and emergent nature effecting the policy of the Federation on behalf of the Board of Directors. The matter should be placed before next Managing Committee Meeting for confirmation.
