And whereas the charged Officer admitted the articles of charge framed against him and on the basis of Inquiry Report and on humanitarian ground, the Disciplinary Authority proposed to imposed the least severe major penalty under sub-rule(V) of Rule II of the C.C.S (CCA) Rules, 1965 upon the Charged Officer;

Now. therefore, in exercise of the powers conferred by Rule 12 of C.C.S (CCA) Rules, 1965, and in consultation with the Mizoram Public Service Commission, the Governor of Mizoram hereby pleased to order that the Charged Officer Pu F. Lalthlengliana, E. O, re-instated in service forthwith under the following conditions:—

- 1. The period of suspension be counted as on duty for pensionery benefits only under Rule 23 of C.C.S (Pension Rules) 1972 and Govt. of India's Decision No. (1) below Rule 25 of C.C.S (Leave) Rules, 1972. No further financial benefit will accrue to him except for the subsistance allowance already drawn by him during the period of suspension;
- 2. A penalty of reduction to a lower stage in the time scale of pay for a period of  $3\frac{1}{2}$  (three and a half) years without commulative effect and not adversely affecting his pension will be imposed upon Pu F. Lalthlengliana, Employment Officer, under suspension; and
- 3. The period of his unauthorised absence from duty for the period from 1. 12. 98 to 3. 5. 99 except one day each in the month of February and March, 1999 be treated as EOL.
