Instances have come to the notice of the Government that senior Officers approached their subordinate Officers for standing surety for loans taken by them or their family. It has therefore been felt necessary to draw the attention of all Govt. Servants to GID (3) below Rule 16 of CCS(Conduct) Rules, 1964 which provides that senior Officers are not to approach their subordinates for standing surety for loans taken by them or by their relatives. By doing so, superior officers will be putting themselves under obligation to their subordinates and such situation is not conducive to efficient office management and maintenance of discipline. The Government takes a serious view on breach of this rule.

All Secretaries/Heads of Departments are requested to kindly take note of this and also to bring the content of this Office Memorandum to the notice of all Govt. Servants under their control for strict compliance.
