No. B. 18012/1/86-IND, 25th November, 1999. It has been observed that inspite of Circulars issued vide Industries Department Memo even No. dt. 11. 4. 1988, 27. 10. 1988. 17. 1. 1990, 28. 11. 1990, 27. 7. 1998 that Handloom Units in Mizoram should be encouraged by way of purchasing their products for use in different Government Offices and Quarters, Hospitals, Jails, Rest Houses, Institutions etc., many Departments did not comply with such instructions.

In pursuance to decision of Council of Ministers held on 1. 9. 1999, it is hereby reiterated that only handloom materials produced locally should be used for curtains in all Government Offices/Residential Quarters/Rest Houses/Inspection Bungalows/Circuit Houses, Government and Semi Institutions, including Public Sector Undertaking, Corporate and Co-operative bodies. Apart from curtains, locally produced bed cover/sheets etc. should be used in Government/Semi-Government Institutions like Hospitals, Public Health Centres and Sub-Health Centres and Prisons etc.

Handloom products should be purchased from the following chanelising agencies only:

- 1. Mizoram Apex Handloom and Handicraft Co-operative Society linited (MAHI-CO), Republic Road, Aizawl.
- 2. Mizoram Handloom and Handicraft Development Corporation limited (MHH-DC), Industries Building, Khatla and Chaltlang.
- 3. Mizoram Khadi & Village Industries Board (MKVIB), Aizawl.
- 4. Industries Sales Emporium, Aizawl, Lunglei, Calcutta, New Delhi etc.

All Heads of Departments and other Institutions under the Government of Mizoram are hereby directed to place indents of Mizoram Handloom Clothes for all their requirements of curtains etc. with the above chanelising agencies. It may be noted that non-compliance of this instruction will entail appropriate action against defaulting officers.
