No. I & PR. 15/73/25, the 25th. May, 1973. The Administrator of Mizoram is pleased to publish the following Rules of Procedure for inclusion of Newspapers/Periodicals in the Government approved list for receiving Government advertisements (Annexure I) and Rules for Advertisements (1973) (Annexure II) for general information.

### ANNEXURE I

#### RULES OF PROCEDURE FOR INCLUSION OF NEWSPAPERS/PERIODICALS IN THE GOVERNMENT APPROVED LIST FOR RECEIVING GOVERNMENT ADVERTISEMENTS

1. **Short title:**—These rules may be called the “Rules of procedure for inclusion of Newspapers/periodicals in the Government approved list for receiving Government advertisements.

2. **Object:**—The object of the rules is—

- (i) to utilise the approved newspapers and periodicals as mass communication media with a view to secure the widest possible publicity of the Government advertisements,
- (ii) to arrange rational and adequate publicity of the advertisement keeping in view the amount of fund available for purpose;
- (iii) to attract the attention of the classes of readers designed to be reached for the purpose of particular advertisements.

3. **Procedure for application:**—An application for inclusion of a newspaper/periodical in the approved list of the Government is to be submitted by the Publisher of a newspaper/periodical concerned to the Director of Information and Public Relations, Mizoram, Aizawl through the Deputy Commissioner/Subdivisional Officer of the District or Subdivision, as the case may be, from where it is published. The application shall contain the following:

- (i) Name of the Newspaper/Periodical.
- (ii) Name and address of the Editor.

- (iii) Name and address of the Publisher.
- (iv) Name and address of the Printer.
- (v) Name of the Owner of the Printing Press, where the Newspaper/Periodical is printed.
- (vi) Name and address of the Printing Press where the Newspaper/Periodical is printed.
- (vii) Name of the Owner or Owners of the Newspaper/Periodical (mentioning whether ownership is proprietary, co-operative, private limited or trust board)
- (viii) Periodicity of publication.
- (ix) Price per issue.
- (x) Circulation (this should be shown itemwise, namely (a) subscriber copies (b) complimentary copies, (c) voucher copies and (d) exchange copies and areas where it is circulated, (e) Language in which published.
- (xi) Certificate of circulation figure (to be obtained either from the Government Auditor or Deputy Commissioner or Sub-divisional Officer concerned).
- (xii) Whether the newspaper/periodical deals with literary, political or socio-economic aspects or with more than one of those aspects.
- (xiii) Whether the newspaper/periodical has any political affiliation or subscribes to any political ideology or independent.

**4. Conditions for inclusion in the approved list.**—On receipt of the application with the particulars as mentioned in the foregoing provision and after perusal of the Newspaper/periodical, the Director of Information and Public Relations shall forward the application with his views and comments thereon to the Government of Mizoram for its inclusion or otherwise in the list. In deciding as to whether the newspaper/periodical shall be included or not the following factors shall be taken into consideration.

- (a) A Newspaper/Periodical shall maintain at least three months regular publication from the date of its first appearance.
- (b) It shall have a minimum circulation of 500 copies of each issue.
- (c) It shall not publish any news about any affairs connected with the Government which is false and or misleading.
- (d) It shall not contribute anything which is likely to disturb the unity of the nation, spread communal hatred, nor publish scurrilous or obscene materials, nor carry on malicious propaganda against the Government.

**5. Benefits to be enjoyed by Newspaper/Periodical in the approved list.**

A Newspaper/Periodical included in the approved list gets the following benefits :—

- (i) It will be entitled to receive advertisements, press releases and publications subject to the fulfilment of the required standard, viz, class of readership, language and areas intended to be covered, standard of production and adherence to accepted standard of journalistic ethics.
- (ii) Its Editor or his representative (who may be a senior or a special correspondent or a senior staff reporter) will be formally accredited to the Government of Mizoram and in that capacity he or she will have access to Press Conferences, interview Ministers and Secretaries and attend public meeting addressed by the President or Prime Minister of India, and other high dignitaries.

**6. Conditions for removal of Newspaper/Periodical from the approved list.** The name of Newspaper/Periodical may be struck off from the Government approved list under the following circumstances —

- (a) If it publishes scurrilous, malicious, false or obscene writings.
- (b) If it is irregular in publication.
- (c) If its editorials and comments encourage subversive activities against Government established by law, indulge in propagating communal bitterness, preach ideas affecting integration of the country, etc.
- (d) Undesirable display of news items.
- (e) If the paper or journal falls below accepted journalistic standards and could be described as the yellow press.

**7. Procedure for removal from the approved list.** Whenever the Director of Information and Public Relations, Mizoram is of the opinion that any writing or comments in a newspaper or periodical as the case may be, is of such a nature that action may be taken under the preceding rule he may send a report in this regard to the Government of Mizoram and there after the Government of Mizoram may remove the name of the said newspaper or periodical, as the case may be, from the list.

Provided that no such action shall be taken by the State Government until the Publisher of the newspaper or periodical, as the case may be, has been given a reasonable opportunity of showing cause against the action propose to be taken.



**ANNEXURE II****RULES FOR ADVERTISEMENTS (1973)**

1. All the Government Advertisements/Notices for publication in various local Newspapers/Magazines should be sent to the Director of Information, Public Relations.
2. The Department/Head of Office issuing advertisements should send the same at least 20 days ahead of the last date for receiving applications/Tender from the date of despatch and the same should be advertised to the public for at least days from the date of its publication in the paper.
3. The Advertisements/Notices should be published in 3 (three) daily/weekly papers simultenuosly.
4. In case of advertisement to be published/Notices to be published in outside papers i.e. outside Mizoram, the Department/Head of Offices should specifically mention number of insertions desired and the name(s) of paper where the same should be published. In cases of advertisements/notices to be published in local papers, dispersal of advertisement will be done by the Director, Information, Public Relations according to a cyclic order maintained by him.
5. The advertisements/notices should be signed by the issuing authority.
6. The advertisements/notices should be accompanied by 4 (four) spare copies. If the same advertisements/notices are to be issued in the Mizoram Gazette, 2 (two) more copies are to be sent to the Director, Information, Public Relations.
7. All bills for advertisements should be submitted to the Director, Information, Public Relations who will check the same and forward the same with comments to the concerning offices for payment. The Department/Head of Office should disburse the bill to the Paper concerned within one month from the date of receipt of the Bill from the Director.
8. Government Advertisements/Notices are to be issued only to those Newspapers/Magazines which have been approved by the Government to be included in the Government approved list in accordance with the "Rules of Procedure for inclusion of Newspapers/Periodicals in the Government approved list for receiving Government Advertisements".
