Whereas a private member resolution was passed in the Chakma Autonomous District Council winter Session on 9.12.99 for creation of a new Village Council of Charluitlang Sub-Village which was then under Vaseitlang-II Village Council subject to the fulfilment of all required conditions for creation of a new Village Council.

Whereas pursuant upon the above mentioned resolution, the Executive Committee of the Chakma Autonomous District Council conducted verification on the prevailing conditions of the Sub-village and thereupon founded Charluitlang Sub-Village has acquired all such conducive conditions required for a full-fledged Village Council.

Therefore, now in exercise of powers conferred under Section 3 of the PLAR(Village Councils) Acts, 1954, the Executive Committee of the Chakma Autonomous District Council is pleased to declare the Charluitlang sub-Village into a full-fledged Village Council. Provided that the first meeting of Charluitlang Village Council shall take effect from the date of V/Council General Election 2001 to be held on 15/3/2001. In the meantime the existing Village Council member from Charluitlang under Vaseitlang-II Village Council shall look after the executive function of Charluitlang Village Council.
